He added, "We are also dedicating this concert to St. Dominic de Guzman, the founder of the Dominican Order, in the 800th Jubilee of the Order."

UST hosts WIPO meeting to establish IP hubs and spoke in PH HEIs

A meeting was held at the University of Santo Tomas to discuss the critical needs and challenges faced by Spoke in terms of technology development, management, and commercialization in order to address these concerns in 2017 and beyond. The meeting, held on November 11, 2016 at the Rector's Hall, also discussed the past achievements of previous initiatives; and the readiness of the Spokes to commit to the IP Hub project. Leading the discussion was WIPO Director for Asia-Pacific Affairs Andrew Michael Ong.

This meeting was an offshoot of the February 29, 2016 workshop on the IP Hub and Spoke, to help World Intellectual Property Organization (WIPO) and Intellectual Property Office of the Philippines (IPOPHL) identify which among the Higher Education Institutions (HEIs) will be tapped for intensive training on the IP Hub and Spoke.

Represented were WIPO, IPOPHL, UST, Adamson University, Bataan Peninsula State University, Bicol University, Capiz State University, Negros Oriental State University, Palawan State University, University of the Philippines – Diliman, Manila, and Los Baños, University of San Carlos, and the University of Southeastern Philippines.

UST Innovation and Technology Support Office (ITSO) Manager Assoc. Prof. Michael Jorge N. Peralta, said that the meeting will provide a venue for stronger awareness about IP among Philippine HEIs. "This will help WIPO and IPOPHL establish greater connections with HEIs," Peralta added. OVRRI hosted the meeting.

Vice-Rector for Research and Innovation Prof. Maribel G. Nonato, PhD, under whose office ITSO is housed, said that the establishment of an IP hub and Spoke in UST will "expand the functions and responsibilities of the office" in order to better deliver its services.

The IP hub is a mechanism by which IP practitioners can come together as a community and hasten the process of recognizing innovations and technologies and promote these later on to a wider audience.

Benavides Library launches new reading facilities

n support of the library's mission of promoting interest in reading among the Thomasian community, the UST Miguel de Benavides Library launched its Gadget Corner and the Leisure Reading Area on November 8, 2016. These facilities provide an engaging reading ambiance and offer study spaces that are appropriate to the new learning styles of most library users.

The Gadget Corner, which is situated at the ground floor lobby adjacent to the Circulation section, consists of 10 computer tablets consisting of more than 250 electronic books from Gale Virtual Reference Library database. Access to other subscribed library electronic books, e-journals, databases and other resources can also be made using the gadgets. The facility was installed by the CE-Logic Company.

The Leisure Reading Area is designed for light reading in an informal setting. It is a cozy reading space where readers can sit comfortably and relax both their mind and body. Best-seller novels, pocket books and other easy reading materials are available for library users.

UST Education-EdTech partner with UNESCO ICT Bangkok on teacher-training program development

he College of Education and the UST Educational Technology Center have forged a renewed partnership with UNESCO ICT Bangkok to develop a teacher-training program on ICT using Active Learning Approaches for future deployment among Asia Pacific countries through the UNESCO's Resource Distribution and Training Centers. The UST group composed of College of Education Dean Prof. Allan De Guzman, Ph.D., Educational Technology Center Director Asst. Prof. Anna Cherylle M. Ramos, and two e-Learning specialists from the College of Education, Ms. Maria Mercedes Buendia and Ms. Pri-Ann Tinipunan, conducted a preliminary workshop, "Learn to Engage, Engage to Learn in a Digital Environment" during the Regional Seminar for UNESCO Resource Distribution Training Centre (RDTC) held from November 23 to 25, 2016 at The Landmark.

The workshop focused on achieving critical thinking. A prototype lesson was used active learning to keep students engaged as a discussion space for the participants for a successful learning outcome. The resource speaker from Belgium, Dr. Marina Reimslagh, introduced the Psychological Kinesiology or PSYCH-K therapy model as a new approach in handling drug counseling cases in the Philippines. The PSYCH-K approach taps the person's subconscious in eradicating the negative stressors related to the sensory signals received and felt by the individual, totally eliminating one's lingering distress. To further understand this approach, Reimslagh conducted a sample case demonstration with the participation of Ms. Mary Rachelle Batanes from UE.

Ong, Maruquin attend QS-APPLE conference- exhibition in Malaysia

Quality Management Office (QMO) Assistant Director Nestor R. Ong, ASEAN Engr., and QMO Auditor Eugene B. Maruquin II, participated in the three-day 12th QS-APPLE Conference and Exhibition, themed 'New Directions in Asia-Pacific Higher Education: Challenges and Opportunities,' held at the Putrajaya International Convention Centre in Putrajaya, Malaysia from November 22 to November 24, 2016.

The University of Santo Tomas (UST) had an exhibition booth, together with higher education institutions from the Philippines such as the Lyceum of the Philippines University, Mapúa Institute of Technology, De La Salle University, San Pedro College, University of Perpetual Help System - Biñan Campus, and University of Mindanao. The minister of higher education of Malaysia dropped by the UST booth and had a short talk with Engr. Ong about the university. Foreign delegates who visited the UST booth expressed their interest in developing partnerships with the University through a memorandum of understanding.

At the opening plenary, the 12th QS-APPLE Creative Awards ceremony was held. UST won the Silver Award for Most Creative Corporate Institution Video, now its second award. The first was the Bronze Award for Best International Website Page in the previous year's QS-APPLE event held in Melbourne, Australia. For this corporate video, QMO worked in collaboration with the Office for Admissions.

The conference convened over 700 academics from 232 institutions in 39 countries, which is said to be recordbreaking. A total of 77 papers were presented during the plenary and parallel sessions; and 67 exhibitors showcased their respective university offerings at the QS Hub – Exhibition.

Countries represented at the conference were: Australia, Bahrain, Brunei Darussalam, Canada, China, Egypt, Fiji, Finland, Germany, Hong Kong, India, Indonesia, Japan, Jordan, Kazakhstan, Kenya, Kuwait, Lebanon, Lithuania, Malaysia, Mexico, Mongolia, Pakistan, Palestine, the Philippines, Poland,



Qatar, Russian Federation, Saudi Arabia, Singapore, South Korea, Sweden, Taiwan, Thailand, United Arab Emirates, United Kingdom, United States, Uzbekistan and Vietnam. The conference was supported by the Malaysian Ministry of Higher Education as well as the Federation of Indian Chambers of Commerce and Industry (FICCI) and the Education Promotion Society for India (EPSI) as strategic partners of 12th QS-APPLE, which resulted in strong participation of educators from Malaysia and India.

As in the previous years, QS Stars certificates were awarded to dynamic universities that take their internationalization efforts seriously. The highlight of the 12th QS-APPLE event was the launch of QS's latest addition to its rankings portfolio: the QS University Graduate Employability Ranking, which was conducted during a 90-minute panel discussion featuring topclass speakers. There was also a session on the rankings of ASEAN universities, chaired by the head of QS Intelligence Unit.

The most sought-after activity in QS Asia conferences – QS Squared Debate – engaged the participants to discuss a controversial topic: 'A university without global aspirations should not be classified as a university.' At the start of the session, 71% supported the motion and 29% were opposed. By the time the discussion had reached its end, the tables turned, the supporters of the motion shrank by almost half, and those who were opposed to the motion more than doubled, making the final poll stand at 36% for the supporters and 64% for the non-supporters.

Three special guests from Malaysia visited the 12th QS-APPLE: His Royal Highness Tuanku Syed Faizuddin Putra, crown prince of Perlis, Malaysia, who gave the welcome address during the opening plenary; Tan Sri Dr Noorul Ainur Mohd Nur, secretary general of the Ministry of Higher Education, who delivered the opening plenary keynote address; and YB Dato' Seri Idris Bin Jusoh, Ministry of Higher Education, who delivered the closing plenary keynote address.

ST Senior High School Assistant Principal for Student Formation Asst. Prof. Mary Erika N. Bolaños, Ph.D., delivered the Keynote Speech on the third day of the Global Colloquium of the Order of Preachers on the theme 'The Way of the Dominican Preacher: Go and Do Likewise.' It was held at St. Louis, Missouri, USA from October 10 to October 14, 2016.

The Global Colloquium was a collaboration of the Aquinas Institute of Theology with the Dominicans in Institute for Pastoral Homiletics in Germany and the Institute for Preaching in the Philippines. Sixty participants from various countries participated in the 800th year celebration of the establishment of the Ordo Praedicatorium (Order of Preachers). The Filipino delegates included Colegio de San Juan de Letran Manila Rector Fr. Clarence Victor Marquez, O.P., Bolaños and Ms. Carla Omania who was moderator for the third day. Bolaños and Omania are both lay preachers from the Institute of Preaching, Philippine Dominican Center of Institutional Studies.

Bolaños' presentation, titled 'Preaching Mission of a Dominican Lay Woman: A Personal Profession of Faith Life,' reflected the goals of the colloquium - to forge an international community in promoting preaching in the Roman Catholic Church.

On November 18, 2016, the second day of the Camp, UST hosted the Opening Ceremonies of the 2016 Asia Religious Youth Peace Camp held at the Benavides Auditorium. With the theme "Responding to the Marginalized Communities' Vulnerability to Climate Change: Strengthening Common Actions and Empowering Asia-Pacific Interfaith Youth Leaders," the Camp was participated in by 60 youth leaders from 12 countries from Asia and the Pacific Region.

The APIYN Grant is awarded by the Religions for Peace Asia (ACRP) to provide seed funding for projects that address the three global issues faced by the youth: violent religious extremism, refugee crisis, and climate change. The Philippine Chapter, together with the Project Proposal by the Mongolian Chapter, are the first recipients of the grant.

The APIYN is the regional body of the Religions for Peace Global Interfaith Youth Network, a coalition which harnesses the energy and commitment of religious youth leaders around the world to advance its mission of multi-religious cooperation for peace. Religions for Peace is the world's largest multi-religious coalition, representing all religions and faith traditions.

The CO training included topics in facilitating and deepening the knowledge, skills and values of the participants on CO steps and processes, community leadership, community communication, community organizing and sustainability plan.

UST passes ISO 9001:2015 Stage 1 Audit, recommended for Stage 2 Audit

n the basis of a successful on-site Stage 1 Audit for ISO 9001:2015 certification, the University was recommended for Stage 2 Audit. This was announced during the Closing Meeting of the Audit held at the Paredes Bldg. on November 16, 2016 by the external lead auditor from TUV-SUD PSB Philippines Mr. Charlie G. Labrador from TUV-SUD PSB Philippines.

Prior to the actual audit was the Opening Meeting to orient the participants on the audit proper and introduced TUV SUD PSB Phil., Inc., an internationally recognized testing and inspection body.

During the Audit Proper, Labrador reviewed the University's existing documentation process to establish if it is in line with the requirements of ISO 9001:2015. Stage 1 was completed on-site to determine if the University's Quality Management System (QMS) has met the minimum requirements of the new ISO 9001 standard and is ready for a certification audit.

Various scrutinizing tasks were performed during the audit proper including: verification of information; review of the scope of the management system; procedure for the identification of proper risk; scope of the relevant legal and other requirements that must be observed; availability of procedures, planning and evidence for internal audits and management reviews, priorities for the planning of stage 2 audit and evaluation of the stage 1 audit results/action list.

Labrador pointed any areas of concern and potential opportunities for improvement of the QMS.

Ngo thanked the members of the Thomasian community who had been part of the preparation for the Stage 1 Audit that eventually led to a very satisfactory conclusion.

Ong further challenged the team for the second stage or the 4th Surveillance Audit, which is a 100% audit across the offices and faculties/ institutes/ schools of the university and encouraged the members to remain positive and optimistic.

International body reaccredits UST Occupational Therapy Program

he Education and Research Committee of the Philippine Academy of Occupational Therapists (PAOT) announced on November 11, 2016 that the Occupational Therapy program of the UST College of Rehabilitation Sciences has satisfactorily met the competencies required by the PAOT and the World Federation of Occupational Therapists (WFOT) thereby acquiring reaccreditation for a five-year period.

Based on the report of the committee that conducted the on-site visit in both the classroom and fieldwork settings from October 3 to 4, 2016, the physical facilities were excellent, and the learning materials were updated, relevant, and accessible. Learning activities were described to be appropriate to the course content and congruent with the intended learning outcomes. The committee commended the department's commitment to shift towards an occupation-based framework in both the classroom and fieldwork settings.

The Task Force praised the Occupational Therapy Department for the significant changes to the program and its continuous commitment to improve on it. The administrative support extended by the University to the College was likewise commended. The OT program is under the College of Rehabilitation Sciences.

Simbahayan, student orgs hold Lumad Advocacy Forum

n advocacy forum and exhibit on the Lumad was held in UST to discuss the concerns of these indigenous people of Mindanao.

Organized by the UST Community Achievers Association (ComAch) and in partnership with the UST Rotaract Club Pharmacy Unit, UST UNICEF Volunteers, UST Musikat, Kabayanihan Youth, ComAch Local Units, Rural Missionaries of the Philippines, and Kadumahan, the UST Simbahayan Community Development Office held the forum and exhibit titled Dialogue of Life: Just Peace for All on October 27 from 1 p.m. to 5 p.m. at the Engineering Conference Hall.

During the dialogue, Association of Community Educators in Mindanao Chair Miguel Ramil noted that the current administration is not addressing concerns of the Lumad, especially their right to education.

Ramil said that such presence of paramilitary forces in the Lumads' soil become a hindrance to the schools and learning centers, tagging the institutions as training grounds for rebellion. Due to this, the Lumads were driven to extend their education somewhere as an alternative.

National Union of Students of the Philippines representative Kevin Castro said that spreading awareness of the indigenous people's situation in the academe would pave the way for concerned parties to help them, especially the children.

The exhibit, which depicts the struggle of indigenous people in their right to life, was mounted at the Tan Yan Kee Student Center lobby.

aculty members, alumni and students of the Department of Physical Therapy of the UST College of Rehabilitation Sciences, participated in the recently concluded "Impetus 2016: The Annual Convention of the Philippine Physical Therapy Association, Inc." The Philippine Physical Therapy Association, Inc., (PPTA) is the accredited professional organization of physical therapists under the Professional Regulation Commission. This year's convention was held on December 10 and 11, 2016 at the Diamond Hotel, Manila, with the theme, "Dynamism...Change...Action."

CRS Dean Assoc. Prof. Cheryl R. Peralta, DrPH, was the Plenary Speaker, and discussed "Developing the New Wave of Filipino Physical Therapists." She likewise served as resource speaker in plenary and parallel sessions, being the as Chair of the CHED Technical Committee for Physical Therapy Education and Member of the CPD Council for Physical Therapy under the PRC.

As panel discussant, Dean Peralta talked about "Understanding the New Policies on Continuing Professional Development" being a member of the CPD Council for Physical Therapy under the Professional Regulation Commission.

During the Parallel Session, Dean Peralta discussed the "Proposed Changes in the Philippine Curriculum for Physical Therapy" which she presented as Chair of the CHED Technical Committee for Physical Therapy Education.

The members of the CRS PT Department likewise presented their research outputs, led by its Department Chair Assoc. Prof. Valentin Dones III, Ph.D., who talked about "Diagnostic Value of Musculoskeletal Ultrasound in Acute and Chronic Lateral Epicondylalgia. Mr. Lemuel Lim discussed "Lived Experiences of Filipino Physical Therapists in Continuing Professional Development - a Focused Qualitative Study"; while Mr. Lyle Patrick Tangcuangco expounded on the "Association of Lateral Epicondylalgia and Shoulder Rotatory Motion: A Cross-Sectional Case Control Study" and Mr. Christopher Cruz talked about "Preferred Learning Strategies of Physical Therapists

Litao, Lustanas share findings on political euphemisms in Philippine context at int'l confab on Language

Rodrigo Litao and Ma. Bridgette Lustanas, faculty members of the Faculty of Arts and Letters, and the former, also the Assistant Principal for Academics of the UST Senior High School, presented a paper on 'Categories and functions of political euphemisms in Philippine online news articles' during the 2nd LITU-CULI International conference with the theme "ELT (English Language Teaching) Unlimited." Organized by the Language Institute of Thammasat University (LITU) and Chulalongkorn University Language Institute (CULI), the conference was held on October 6 and 7 at The Ambassador Hotel, Bangkok, Thailand.

Litao's and Lustanas' paper was about political euphemisms found in 90 online news articles from the three most leading newspaper publications in the Philippines. The goal was to disclose the categories and functions they serve for the Philippine context. Their research revealed that aside from the three classifications: greater deviation from its signified, more vague meanings, and strong characteristics of time using Zhao and Dong's typology, two more surfaced from the data outside of the aforementioned typology, namely: issue moderation and analogous association.

The last two mentioned categories occurred more frequently than the first three ones cited. This paper argues that the two newly identified categories could contribute to the existing literature on euphemisms, particularly in politically-related newswriting

in the Philippine context. It further argues that political euphemisms are employed both as a language of manipulation and mitigation.

Quoting Assoc. Prof. Dr. Porsiri Singhapreecha, director of the Language Institute Thammasat University, the recent conference provided "a venue for researchers to exchange research findings and collaborate on common theoretical interests. It was also a forum for ELT practitioners to reflect upon their methods and contributions within the teaching community."

Keynote speaker was Doris Wibunsin, who has been involved in language teaching and learning in Thailand for more than half a century and who was on the original committee that founded the Thai/TESOL.

Plenary speakers included prominent international language teaching practitioners: Professor Douglas Biber (Regents' Professor of English at Northern Arizona University) who talked about Complexity in academic writing: The development of phrasal discourse styles; Assoc. Prof. Willy Renandya (the National Institute of Education, Nanyang Technological University, Singapore) who shared his expertise on the topic ELT today: Building a closer link between theory and practice: Prof. Winnie Cheng (Associate Dean, Faculty of Humanities, Professor of English and Director of Research Centre for Professional Communication in English, Department of English, The Hong Kong Polytechnic University), who dealt with Data-driven approach to learning

and teaching reporting verbs in research articles; Dr. Suwichit Chaidaroon (Senior Lecturer. Department of Marketing and Business Strategy, Westminster Business School) elaborated on the topic, Beyond ELT Boundaries: Internationalizing tertiary instructions in Thailand in the ASEAN era.

The oral presentations and symposia that took place during the two-day conference consisted of nearly 60 abstracts. covering areas of innovation and second Language enhancement such as task and corpus-based approaches, online learning. language assessment, motivation, action research and curriculum design.

UST administrators exchange views with Asia Pacific HIV/AIDS conference delegates





n November 16, 2016, international and local delegates who attended the 6th Catholic Asia-Pacific Coalition on HIV/AIDS (CAPCHA) Conference arrived in UST for a half-day exposure trip. The CAPCHA, a regional network in the Asia Pacific focusing on human immunodeficiency virus/acquired immunodeficiency syndrome (HIV/ AIDS) and related issues, works for the awareness, prevention, care, treatment and support of individuals living with HIV.

This year's CAPCHA Conference was hosted by the Philippines and was held in Manila from November 13 to 17, 2016. As part of the conference program, exposure trips to educational institutions with HIV/ AIDS awareness and prevention programs and HIV/AIDS treatment facilities and clinics had been scheduled and coordinated by the Catholic Bishops' Conference of the Philippines (CBCP) Commission on Health Care, in collaboration with the Catholic Educational Association of the Philippines (CEAP). UST was one of the schools included in the exposure trip for the participants.

The delegates were welcomed at the Rector's Hall by UST Vice Rector for Academic Affairs Prof. Clarita D. Carillo,

Ph.D. and Counseling and Career Center (CCC) Director Prof. Lucila O. Bance, Ph.D. At the opening program, Dumaguete Bishop Julito Cortes of the CBCP Episcopal Commission on Health Care, together with Myanmar Bishop Alexander Cho of the CBCM Commission for Health Care, gave an introduction of the conference agenda. Institute of Religion Faculty Secretary Asst. Prof. Allan A. Basas, S.Th.D. shared with the participants the integration of HIV/ AIDS in the Curricular and Co-Curricular activities of UST - that at present, there are steps being undertaken to revise the University's curriculum in Theology to improve on the approaches in the teaching of the concept of human sexuality, HIV/ AIDS, and other related issues.

A fruitful discussion and sharing of experiences took place among the participants during the presentation of best practices in the University and open forum facilitated by Bance. The forum highlighted the programs, modules, activities, and research endeavors by the CCC in collaboration with the UST Health Service regarding the awareness and prevention of HIV/AIDS. There was also an exchange of ideas on how to diminish the stigma in seeking the help of mental health professionals in general. After the

The College of Science organized the 3rd International Symposium on Molecular Science (ISMS) which was held on December 1 and 2, 2016 at the Benavides Auditorium, with ten local and ten foreign experts as speakers. The two-day symposium had four sessions in the areas of: Biophysics and Analytical Sciences, Biodiversity and Environment, Materials Science and Nanotechnology, and Health and Biomedicine.

The 3rd ISMS, which coincided with the celebration of the 90th year of foundation of the college, served as a platform for research dissemination and academic discourse, provided a venue for research collaboration, fostered international cooperation through academic and research partnership, and promoted the Sciences to young Filipinos. Notably, the importance of interdisciplinary and collaborative research was epitomized as non-Thomasians were invited to interact with the presenters and to look for possible future research collaborations. High school students were invited to promote the sciences as a possible future career option. To emphasize, Dean John Donnie A. Ramos, Ph.D., invited the participants and guests to "listen, interact, and forge collaborations with the speakers." Nagova City University Vice President Prof. Yuji Imaizumi, Ph.D., was auest.

Moreover, the strive for excellence by the College of Science resonated in this year's theme, "Interdisciplinary and Collaborative Research towards Intellectualization" as stated by Office of International Relations and Program Director Prof. Lillian J. Sison, Ph.D., in her opening remarks. This symposium gave opportunity to researchers to share one's techniques and ideas in solving scientific problems – providing an environment that allows different researchers to collaborate. Furthermore, this provided research opportunities for students to contribute in the solution of regional and global concerns. Beyond this, however, the symposium provided means to deepen relationship and appreciation of one another's culture.

Lintao, whose research interest has been translated into an advocacy in promoting the plain language movement, showcased in her paper, the development of the continuing effort that she is pursuing, which is the presentation of the document's simplified version to the legal department of the company and strategizing for lobbying the Plain Language Bill at the Phillipine Congress.

Clarity is a worldwide organization of lawyers, academics, linguists, information design specialists and other professionals who advocate the use of plain language in documents. Lintao serves as Clarity's Country Representative to the Philippines.

This seventh biennial conference titled, 'The business of clarity: A plain language conference for law, government and business', gathered over 200 participants from all over the world. The event brought together world leaders such as Western Michigan University- Cooley Law School Distinguished Professor Emeritus Joseph Kimble: United Nations High Level Panel on Health Technology Innovation and Access Hon. Michael Kirby, also a former judge of the High Court of Australia; and New Zealand Solicitor-General Una Jagose.

AB Pol Sci students present paper on Security and Peace at Int'l Relations conference in Indonesia

arla Michaela B. Taguinod and Mariel Encar H. Uy, both fourth year Political Science students from the Faculty of Arts and Letters, presented their paper during the International Conference on International Relations held on October 27. 2016 at Mercure Hotel, Bandung, West Java, Indonesia. The conference, whose theme was "Human Security: Safeguarding and Empowering People", was a professional and academic gathering of participants who represented organizations and institutions from different countries and delivered their paper on issues involving human security in connection with the Cold War. This international congress aimed to discuss and contribute to the innovation of the idea behind human security.

Taguinod and Uy were the only undergraduate students among the paper presenters under the theme 'Regional and Global Initiatives.' Their paper titled "Nuclear Arsenal: Building Security, Threatening Peace" discussed the contemporary stand of Australia on the Austrian-led nuclear disarmament and non-proliferation treaty.

It has been reported that for the past years, Australia has supported advocacies regarding nuclear ban. However, with the Vienna Conference that was held on December 2014. Australia failed to show its support to the NPT initiative. Taguinod's and Uy's paper analyzed the reasons for Australia's decision to take a different path on this nuclear issue and how its change of course affects their domestic and international relations with those countries that possess nuclear weapons. The paper also revisited the history of nuclear weapons and its role in the international arena, the past involvement of Australia regarding NPTs and the state's nuclear capability.

The study explored the condition of Australia's international relations especially with countries that possess nuclear arsenals such as the United States of America and India. It also analysed the variables that make Australia a significant figure in cases associated with nuclear covenants such as the country's supply of Uranium and bases built for nuclear facilities. The nuclear interdependence of Australia is a

model that was used in their research to fully comprehend the state's stand on the Austrian-led humanitarian pledge.

The keynote speakers were Lt. Gen. (Ret) Agus Widjojo, the governor of the National Resilience; Luc Haas, head of the International Committee of the Red Cross Regional Delegation for Indonesia and Timor Leste; and Mark Getchel, chief of Mission IOM Indonesia

The second plenary session was initiated by Prof. Bob Sugeng Hadiwinata from the International Relations Department of Parahyangan Catholic University. He was followed by Professor Brendan Howe, the associate Dean at the graduate school of the International Studies Ewha Womans University, South Korea and also the current president of the Asian Political and International Studies. The session was concluded by Professor Alan Collins from the department of Political and Cultural Studies Swansea University, United Kingdom.

Arriola delivers Marcello Casillan research project output

De Viana of AB presents paper at confab in Japan on Quirino's pardoning of POWs

ST History Department Chair Associate Professor Augusto V. de Viana, Ph.D., presented his paper at the joint conferences of the Pacific Conference on Security (APSEC) 2016 , Asia Pacific International Studies Association (APISA) held on December 8 and 9, 2016 at the University of Osaka Nakanoshima Center.

The joint conference, which discussed security and diplomatic issues in the Asia-Pacific region, was organized by the International Academic Forum (IAFOR) and co-sponsored by the University of Osaka, Japan.

In his paper titled "Ending Hatred and the Start of Healing: President Elpidio Quirino's Pardoning of Japanese War Prisoners in July 1953 and its Effects," de Viana discussed the personal and political dilemma faced by President Quirino when he issued an executive clemency allowing the last remaining Japanese war criminals in the Philippines to return to Japan. The executive clemency freed 32 prisoners, reduced the death sentences of 27 Japanese convicts facing the death penalty to life imprisonment and and 56 others were to serve definite sentences in Japan. De Viana said that the pardon was greatly appreciated by the Japanese government and people who urged other countries to follow the example of the Philippines. While Quirino lost his bid to be reelected as President of the Philippines in 1953, his selfless act played an important role in the reestablishment of Philippine-Japanese diplomatic relations and more than 70 years after the end of World War II both countries were the closest of allies in political and economic matters.

Peralta of CRS presents paper on challenges in health research ethics at PHREN Scientific Assembly

Prof. Michael Jorge Peralta, presented a paper during the Philippine Health Research Ethics Network (PHREN) 2nd Scientific Assembly on "Controversies and Challenges in Health Research Ethics" held on October 25 and 26, 2016 at the UNILAB Bayanihan Center, Pasig. He discussed the common issues in undergraduate student research studies and their possible solutions, and proposed that research studies be faculty-led in order to achieve good quality.

Then Typhoon Lawin hit provinces in Northern Luzon last October, Thomasians launched a Tulong Tomasino campaign to collect donation of relief goods and cash donations to aid those who were affected by the typhoon. Guided by the Tulong Tomasino Disaster Response Protocol, the University of Santo Tomas community pulled resources together to come up with financial and material contributions.

As a result of these concerted efforts from the Thomasian community, the UST Simbahayan Community Development Office, in close coordination with the Archdiocese of Tuguegarao, personally delivered the cash donations and relief boxes for the victims of Typhoon Lawin on December 7 and 8, 2016. A total of PhP 350,000.00 in cash was turned over to fund the construction of ten new typhoon-resilient but culturally-friendly houses for the Agta Community being supported by the Franciscan Apostolic Sisters (FAS) in Sta. Ana, Cagayan. The UST Simbahayan was also able to distribute 122 boxes of relief goods, three sacks of National Service Training Program (NSTP) hygiene kits, and one box of medicines to the residents of Brgy. Nag-Uma, Sto. Niño, Cagayan. The community beneficiaries were referred by the Social Action Center of the Archdiocese of Tuquegarao as a result of its survey and needs assessment pertaining to the extent of damage the typhoon caused the community.

During the courtesy call of the UST Simbahayan team on Archbishop Sergio L. Utleg, DD, of the Archdiocese of Tuguegarao, he personally relayed his appreciation and recognition for UST and the Thomasians who generously shared their resources and efforts to be able to assist the victims of Typhoon Lawin in his locale. Through its Social Action Center, the Archdiocese of Tuquegarao will remain in close coordination with Simbahavan for the monitoring of the rehabilitation efforts in the affected communities.

The Usapang Business program is a Pre-Pistang Tomas event. The Pistang Tomas, an annual Simbahayan activity, will be held from February 13 to 16, 2017 at the UST Quadricentennial Square.
