## 77<sup>th</sup> anniversary of UST's liberation as an internment camp, Battle of Manila commemorated

Seventy-seven years after the Battle of Manila and the liberation of the Santo Tomas Internment Camp, the University of Santo Tomas, with the City Government of Manila through the Department of Tourism, Culture, and Arts of Manila (DTCAM), hosted the commemoration on February 3, 2022. A solemn wreath-laying ceremony and 21gun salute were held in the Plaza Mayor followed by a reception program at the Benavides Garden.

Gracing the event were foreign diplomats, namely, Her Majesty's Ambassador of the United Kingdom of Great Britain and Northern Ireland Her Excellency Laure Stephanie Beaufils; the Ambassador of Canada His Excellency James Peter MacArthur; the Ambassador of Australia His Excellency Steven James Robinson, AO; the Ambassador of Japan His Excellency Koshikawa Kazuhiro; and Acting Deputy Chief of Mission of the Embassy of the United States of America Mr. David "Chip" Gamble, Jr.

Armed Forces of the Philippines Vice Commander MGen. Nestor Herico, PN(M); National Historical Commission of the Philippines Chairman Dr. Rene Escalante; Manila City Mayor Hon. Francisco Domagoso and Vice Mayor Hon. Maria Sheilah Lacuna-Pangan, M.D., also took part in the ceremonies. Along with the diplomats, they offered wreaths at the façade of the Main Building as a sign of respect and remembrance.

UST Rector Very Rev. Fr. Richard G. Ang, O.P., Ph.D., in his speech, bid the audience to focus on remembrance.

"We remember the courage of nameless civilians and the unimaginable suffering of those who experience the desolation of war. Remembering is part of healing; we can only make sense of the past by our ability to retell the story and acknowledge the pain inflicted. We cannot

bring back the lives sacrificed during this period of history, but through this memorial we continue to honor their exceptional courage and valor." emphasized the Father Rector.

It is through remembrance that historical events such as this are preserved in the collective memory for posterity, shared Fr. Ang. He added that the gathering was not only a celebration of history, identity, community, and friendship, but an enabling of peace.

Vice Mayor Hon. Maria Sheilah Lacuna-Pangan, M.D., who obtained her undergraduate pre-medical degree in Biology from UST, highlighted the lessons of heroism learned from the Battle of Manila, likening it to the current challenge of the pandemic.

"No weapons of war are needed, but great heroic challenges remain for the heroes of the present times. As we commemorate the Battle of Manila, we also honor the heroism of the medical health workers," said Lacuna-Pangan, who continued to thank all who were involved in aiding Filipinos as they weathered the pandemic.

Manila City Mayor Hon. Francisco Domagoso, in his message, extolled the virtues of patriotism and love of one's own country. In the modern context, these virtues can also manifest in the valor of medical frontliners protecting people from COVID-19.

"We are now in the middle of a conflict with a virus that left no one unaffected. Just as the brave soldiers whom we relied upon the armed battle; we have our courageous frontliners who never turned their back on us when we needed them the most. Our country's medical professionals live truthfully to their Hippocratic Oath as they display their selflessness," Mayor Domagoso concluded.

UST became the largest internment camp in the Philippines after the Japanese forces occupied Manila in December 1941. For 37 months in captivity, around 7000 people were kept inside, with a few thousand being transferred to Los Baños Internment Camp. Although the internees were initially allowed to continue schooling and to keep a vegetable garden, they suffered an increasingly brutal treatment and prolonged deprivation of food and medicine as the Japanese continued to lose World War II.

On February 3, 1945, the Cavalry Division reached Manila and began the liberation of less than 4000 internees, of which 3000 were Americans, through the guidance of Captain Manuel Colayco - a UST faculty member and a guerilla intelligence officer - who was mortally wounded in the attempt. Colayco Park in UST would later be named after him. The internment camp was finally emptied in September 1945.

Since then, the University of Santo Tomas has hosted previous anniversary commemorations of this historical event, such as the 50<sup>th</sup>, 60<sup>th</sup>, 70<sup>th</sup>, and the 75<sup>th</sup>.

For this year, the Manila Public Information Office livestreamed the event through their Facebook page, where it remains available for public viewing.

#### UST research team reduces food waste, develop vegan sausage from soy byproducts

UST research team, led by UST Graduate School Secretary Assoc. Prof. Elizabeth H. Arenas, Ph.D., sought to reduce food waste through the development of "soysage," a gluten-free, vegan sausage made from okara, the pulp that remains after pureed soybeans are filtered in the production of soy milk and tofu.

Arenas presented the research project during the Department of Science and Technology Collaborative Research and Development to Leverage Philippine Economy (DOST-CRADLE) symposium held on January 18, 2022.

Industrial food processing generates massive amounts of waste, and the unused byproducts, which are commonly disposed of and not maximized, lead to environmental problems and economic loss for businesses, particularly micro, small, and medium enterprises (MSMEs).

Banawe Soybean Curd Food Products Corporation (BSCFPC), which produces soy milk, taho, and bean curd sheet products, also generates 200kg to 300kg of okara as a byproduct. They linked with the UST team through the DOST's Government-Academe-Industry or GAIN workshop held in August 2019, and the one-year research project to make use of okara officially commenced on June 6, 2021.

The world production of okara, mostly coming from Asian countries, is about 1.4 billion tonnes, according to the team's presentation. This large quantity of food byproduct is discarded or used as animal feed. To reduce food waste, the okara will be made into a high-volume food product, such as sausages.

The project's team leader Arenas shared in an interview that, "Currently, there is a strong market demand for sausages, but unfortunately, hiah consumption of processed meat products like sausages is associated with an increased risk of chronic diseases. Thus, we envision a healthy vegan sausage made from okara, which is free of artificial food coloring and chemical preservatives." Okara is a low-

cost source of bioactive compounds that are good for human health. It is high in dietary fiber and contains an appreciable of protein, oil phytochemicals, such as isoflavones, added Arenas. At present, the

#### Architecture faculty members underscore resiliency of Filipino architects at two int'l conferences

n two separate online conferences, UST College of Architecture academic staff presented their studies about the resiliency of Filipino architects in the academe.

Ar. John Clemence Pinlac, Ar. Noel Cruz, and Ar. Caryn Paredes-Santillan, Ph.D. presented their research that focused on the condition of educators in the architecture field during the shift to online architecture design learning due to the pandemic. This study on resilience was based on a previous study on Human Capital Future Resilience by Visser, whose framework they applied in their analysis. Although resilience is a common topic especially now with a global pandemic, studies that focus on human capital resilience is very scarce. In particular, their research focused on the architectural design studio, which is the cornerstone of architectural education.

Pinlac, Cruz, and Santillan presented their paper "Resiliency of the Architects in the Academe: A Qualitative Focus on the Virtual Architectural Design Studio in the Philippines" during the eLearning Forum Asia 2021 (eLFA 2021) with the theme "Augmenting the Virtual Environment: Technology – Innovation – Humanity". In their discussion, the team discussed their findings that high individual resiliency could be maximized, and organizational resiliency should be supported. Furthermore, their data highlighted that low resource efficiency, which includes internet connectivity, available workspaces, and technological tools and resources, need to



be addressed for the optimal performance of educators.

In another conference, the ASEAN-QA Forum 2021 with the theme "The Way Forward: Assuring Quality in Diverse and Remote Learning Environments", the same team presented their paper "Human Capital Future Resilience Analysis: Perspective from Virtual Architectural Education in the Philippines." Similar to the earlier paper, this research built upon the hypothesis that there was a correlation between the profile of the architects in the academe and their resiliency during the online teaching setup. Their data showed that long-time faculty members, those with 30+ years of teaching experience, had the most difficulty adjusting to the online architectural design studio. It was recommended that schools should properly investigate and address

their concerns proactively through proper support or possible partnering activities between senior and junior faculty members.

Aside from teaching at the College of Architecture, Pinlac is also the Chairman for the Committee on Research and Academic Institutions under the Commission on Education of the United Architects of the Philippines (UAP). On the other hand, Santillan is the present College of Architecture Pedagogical Lead.

The eLFA 2021 was hosted by Soegijapranata Catholic University in collaboration with eLFAsia and the United Board of Christian Higher Education in Asia. Meanwhile, the ASEAN-QA Forum is organized by the ASEAN-QA Association (ASEAN-QAA), an organization involved in the development of quality assurance in academic institutions in Southeast Asia.

#### **Thomasian priest** Msgr. Catalan is new **Apostolic Nuncio to** Rwanda

is Holiness Pope Francis appointed Thomasian Monsignor Arnaldo Catalan as the new Apostolic Nuncio to Rwanda in Africa. He was conferred the episcopal ordination at the Manila Cathedral on February 11, 2022.

His Eminence Cardinal Luis Antonio Tagle, the Prefect of the Congregation for the Evangelization of Peoples, was the principal consecrator, accompanied by the Apostolic Nuncio to the Philippines His Excellency Most Rev. Charles John Brown, KC\*HS, and the Archbishop of Manila His Eminence Most Rev. Jose Cardinal Advincula, D.D.,

Rev. Msgr. Catalan, now Archbishop of the Titular See of Apollonia, is the first priest of the Archdiocese of Manila to become a Nuncio. Cardinal Advincula said in a statement. His new post was first announced by the Archdiocese of Manila on January 31. 2022.

Before his latest appointment, he was Chargé d'affaires of the Apostolic Nunciature in China in 2019. Prior to that, he was the first counsellor of the Apostolic Nunciature in Manila.

Msgr. Catalan is the latest Thomasian to be appointed to a Nunciature. He joins Archbishop Bernardito Cleopas Auza, D.D., who was most recently the Apostolic Nuncio to Spain and Andorra in 2019.

#### **Dela Cruz of Science appointed member of DepEd Teacher Education Council**



ST College of Science academic staff Prof. Thomas Edison E. Dela Cruz, Dr. rer. nat., was appointed to represent science teachers at the Department of Education (DepEd) Teacher Education Council (TEC). He will serve a three-year term beginning February 2022.

Included in the functions of the TEC are formulating policies and standards for teacher education, reviewing curricula and programs for teacher training, adopting incentives for scholarship grants and other benefits to encourage more students to pursue teacher education, designing programs to enhance pre-service teacher training, in-service training, and teacher development, among many others.

Dela Cruz, who also teaches at the Graduate School and is a researcher at the UST Research Center for Natural and Applied Sciences (RCNAS), is a Metrobank Foundation Outstanding Filipino Teacher (2015). He was awarded The World Academy of Sciences (TWAS) Prize for Young Scientists in the Philippines - Biology in 2014 and the National Academy of Science and Technology (NAST) Outstanding Young Scientist in the field of mycology in 2012. He has conducted research fellowships in Germany, Austria, China, and the US.

#### "Persevere in hope," urged Cardinal Advincula at St. Thomas Feast Day Mass

anila Archbishop His Eminence Jose Cardinal Advincula. D.D., presided over the Eucharistic Celebration for the feast day of St. Thomas Aquinas, patron of all Catholic universities for whom UST was named.

The Mass, held on January 27, 2022, was concelebrated with the Prior Provincial of the Dominican Province of the Philippines Very Rev. Filemon I. Dela Cruz, Jr., O.P., the UST Rector Very Rev. Fr. Richard G. Ang, O.P., Ph.D., and the Dominican Fathers, at the Santísimo Rosario Parish Church through hybrid modality.

For this year, the theme of the Feast Day celebration was "Saint Thomas: Beacon of Hope and Perseverance."

In his homily, Cardinal Advincula noted that the theme was timely and relevant. "given what we have been through the past two years of the pandemic, as an educational institution and in our personal lives "

"Both teachers and students know the perseverance needed in online teaching and distance learning. Both staff and administrators hope for the end of the pandemic, for a safer and more suitable environment to work and study," the Cardinal explained.

Despite the difficulties, the Cardinal urged the faithful to follow St. Thomas' example of persevering, hoping, and holding on to his faith. His family was originally opposed to his desire to become

a Dominican and placed him under house arrest for a year, but St. Thomas' determination remained strona.

Eventually, St. Thomas would produce prodigious scholarly work through faith, reason, and the scientific manner of theologizing. He contributed immensely to philosophy and theology, and remains a guiding light and pillar of thought for over 700 years.

"It is important to persevere in this mission of education and formation-pandemic or no pandemic-if it is our hope to produce Catholic students who are committed, compassionate, and competent to face the questions and challenges of our time." emphasized the Cardinal.

The Manila Archbishop concluded his homily with a prayer that, "Like St. Thomas, we persevere in hope so that they may see goodness in your acts and give praise to you, Heavenly Father, so that all of our lives will be for the love of Thee." Cardinal Advincula, who underwent

the Rite of Profession to commit himself to the Order of Preachers in December 2021. was formed as a diocesan seminarian in the UST Central Seminary in Manila. Later, he took up Canon Law Studies at the Pontifical University of St. Thomas Aquinas (Angelicum) in Rome, Italy,

### **CTHM students bag awards in int'l global** revenue management contest

homasian excellence is once again recognized as CTHM students Mr. Thor Terenz T. Manuel and Ms. Kane Ellisha Reyes were part of the winning teams that won first and third place, respectively, at the International Centre of Excellence in Tourism and Hospitality Education (THE-ICE) Global Revenue Management (GRM) Challenge.

THE-ICE GRM Challenge is an international student competition exclusively for students of accredited member institutions. It brings together students and academic staff from around the globe and provides opportunities to engage collaboratively and build international skills.

The competition was able to bring together 55 students from ten institutions who were grouped into international and inter-institutional teams of four to six members. Each group was tasked to compete in challenges that tested and developed their hospitality and tourism revenue management skills over several months.

Manuel was part of Team 7, which won first place. Members of the team were from William Angliss Institute, Far Eastern University, and Lyceum of the Philippines University.

Meanwhile, Ms. Kane Ellisha Reyes, was from Team 9, which won third place. She was joined by students from Hotel Management School Maastricht, Singapore Institute of Technology, Far Eastern University, and Lyceum of the Philippines University.

Coached by their adviser, Mr. Dennis Lemsic, the two students received free registration on the Hospitality Business Acumen (HBA) Certificate Program offered by Russell Partnership Technology.

As part of the winning team, Manuel also received a \$AUS 1500 bursary for education offered by any member institution of THE-ICE and a free registration on the Certification in Advanced Hospitality and Tourism Industry Analytics (CAHTA) offered by the Smith Travel Research - Supporting Hotel-related Academic Research and Education (STR-SHARE) Center.

#### **Apostolic Nuncio honors "Samurai of Christ"** at Bl. Takayama's Feast Day Mass

Apostolic Nuncio to the Philippines His Excellency Charles John Brown, KC\*HS, underscored the unfailing devotion to the faith displayed by the Samurai of Christ, Blessed Justus Takayama Ukon, at the martyr's Feast Day Mass on February 3, 2022.

Born in Takayama village, in Toyonocho, Osaka Prefecture, Takayama Ukon was a former samurai turned Catholic

layman who was considered a pillar of the early Church of Japan. He was baptized at 12 years old, taking the name "Justus". during a time when Christian persecution was rampant.

Bl. Takayama, accompanied by around hundreds of Japanese Christians, was exiled to Manila in December 1614 for refusing to abjure his Catholic faith. He turned over an image of the Blessed

Virgin Mary to the Dominican friars in Santo Domingo in Intramuros. The image, known as "La Japonesa", remains in the Santo Domingo Church in Quezon City. He died in Intramuros, Manila on February 3, 1615, only 44 days after arriving in Manila

"He represents an admirable example of fortitude in the faith and dedication in charity. This is the glory of Blessed Takayama. The fact that he was able to sacrifice his honor and homeland for the sake of Christ," emphasized Most Rev. Brown.

The Apostolic Nuncio prayed, "that we may have the grace to imitate [Bl. Takayama], his steadfastness in his spiritual combat, and his love for our Lady, and in his triumph over sin and death."

In 1630, a petition was presented to the Vatican by the Archdiocese of Manila for BI. Takavama's beatification. In the 1980s, a historian and alumnus of the UST Graduate School, Dr. Ernesto de Pedro, was commissioned to study the cause since the petition for Takayama's beatification was revived. In 1989, de Pedro established the Lord Justus Takayama Professional Chair in Philippine-Japanese Studies at the University of Santo Tomas.

Bl. Takayama was Beatified in Osaka on February 7, 2017. His statue is hosted at the Blessed Lord Justus Takayama Sanctuary in front of the Thomas Aquinas Research Center.

## **UNESCO** accredits CTHM Students **Tourism Society - first in PH**

Serving as the speaker was the Founder of the Center for Entrepreneurship and Innovation of the City College of San Francisco, California, Affiliate Professor Vivian Faustino. She is a graduate of UST Business Economics Class of 1988.

The theme, "The impact of recession

to the business sector," focuses on the effects of the pandemic that started in early 2020. In the business sector, micro and small businesses needed to close because they can no longer recover from losses due to extended lockdown measures.

One of the safety nets present in the that this was not enough because the economy still declined after a year. The latter half of 2021 marked the attempt of the government to lighten the restrictions in hopes of economic recovery.

On a global scale, the economy remains in a slump. Faustino noted that the Philippines declined in the Global

Competitiveness Index due to the pandemic. The GCI includes indicators of infrastructure. information communications technology adoption, stability, macroeconomic efficiency enhancers, and innovation factors that determine the level of competitiveness of a country.

To recover, Faustino recommended dynamic reallocation of human resources; the normalization of the ability to launch and dissolve small, agile teams for swift issue resolution and opportunity capture; having faster and 'flatter' organization structures to streamline communication flows; and rapid decision making at the leadership level.

#### **Reyes of Educ delivers lecture on Filipino Studies** program at Hawaii university

ollege of Education Department of Secondary Education Chair Asst. Prof. Alvin Ringgo C. Reyes, delivered a virtual quest lecture in the Filipino Studies Program of the University of Hawaii at Hilo, USA, held from February 7 to 11, 2022.

Reves mapped the historical role of the University of Santo Tomas (UST) in Philippine society to his audience composed of students of FIL 432 Spanish Heritage in the Philippines, ANTH354/ FIL354 Filipino Culture, and FIL 333 Filipinos in Hawaii, comprised of heritage learners of various ethnicities, and nationalities.

"UST, the oldest university in Asia, remains to be timeless, yet timely. As one

#### **UST GS CCCPET lead post-Typhoon Odette** assessment on Church cultural heritage in **Diocese of Maasin**

he UST GS Center for Conservation of Cultural Property and Environment in the Tropics (CCPET), in its capacity to help in the preservation of cultural heritage, visited churches around the Diocese of Maasin to assess the general condition and post-Odette damages on heritage churches of the Diocese.

The onslaught of Typhoon Odette in Northern Mindanao and Visayas last December 2021 left eight provinces---Surigao del Norte, Southern Leyte, Bohol, Cebu, Negros Occidental, Negros Oriental, Guimaras, and Palawan without electricity, communication, food, and water. Aside from these, important infrastructures were also damaged-including heritage and culture sites.

The schedule included an online inception meeting attended by representatives from UST GS CCCPET. UST Faculty of Engineering, the Association of Structural Engineers of the Philippines (ASEP), Diocese of Tagbilaran, Diocese of Talibon, Diocese of Maasin, and the National Commission for Culture and the Arts.

The on-site debriefing was held on January 8, 2022, in San Miguel, Leyte attended by representatives from the Diocese of Palo, Diocese of Maasin, Office of Congressman Ching Veloso, and the CleMend Construction Company. The field evaluation covered heritage churches such as the Maasin Cathedral Complex, Amparo Chapel in Macrohon, Malitbog Church, San Juan Church, Matalom Church Complex, Hilongos Church Complex, Punta Chapel and the Baybay Church.

Fr. Mark Vincent Salang, Diocesan Chancellor who heads the Church Heritage Commission and an alumnus of the UST Central Seminary, was deputized by Maasin Bishop Most Rev. Precioso Cantillas D.D., to oversee the safeguarding, conservation, and rehabilitation of the heritage churches.

Aside from assessing damages to churches around the Diocese of Maasin. CCPET's initiative also aims to provide church-specific and diocesan-wide recommendations to rehabilitate the church complex and collections, and to formulate climate change resiliency and church cultural heritage protocols (principles and guidelines) that could be integrated in the

development of the church's conservation management plan.

UST and the Diocese of Maasin have a standing and active Memorandum of Understanding (MOU) in church heritage conservation and research. The UST GS CCCPET response mission was logistically supported by the Department of Tourism Region 8, under the leadership of Dir. Karen Tiopes; The Farm Guinciaman; Congressman Ching Veloso of the 3rd District of Leyte; Board Member Anna Veloso-Tuason; and the Office of Mayor Jose Carlos Cari of Baybay, Leyte.

The Center organized the Church Heritage Response Team (CHREST) composed of specialists, namely, Assoc. Prof Eric Babar Zerrudo, Ph.D. (Heritage and Development), Prof. Regalado Trota José (Church History and Archivistics). Asst. Prof. Michael Manalo (Church Architecture), De La Salle University Prof. Lessandro Garciano of Ph.D. (Heritage Engineering), Mr. Joselito Corpus (Architectural Conservation), Ar. Cham Odan (Project Management), Mr. Jefferson Chua (Climate Change), and Ms. Beverly Bautista (Coordination).
