PRINCIPAL PATRONESS OF THE PHILIPPINES

The Catechism of the Catholic Church (cf. nos. 490-491) states that “to become the mother of the Savior, Mary ‘was enriched by God with gifts appropriate to such a role.’¹ The angel Gabriel at the moment of the annunciation salutes her as ‘full of grace’ (*Lk* 1:28). In fact, in order for Mary to be able to give the free assent of her faith to the announcement of her vocation, it was necessary that she be wholly borne by God's grace.” In 1854, Pope Pius IX proclaimed the Dogma of the Immaculate Conception of the Blessed Virgin Mary.²



⁴ Republic Act no. 10966 was signed by Pres. Rodrigo Duterte on 28 December 2017: “An Act Declaring December 8 of Every Year A Special Non-working Holiday in the Entire Country to Commemorate the Feast of the Immaculate Conception of Mary, the Principal Patroness of the Philippines.”

⁵ Code of Canon Law no 1247: “On Sundays and other **holy days of obligation**, the faithful are obliged to assist at Mass. They are also to abstain from such work or business that would inhibit the worship to be given to God, the joy proper to the Lord's Day, or the due relaxation of mind and body.”
