

UST's month-long *Paskuhan* celebration features Pinoy superhero-inspired decorations, concerts

fter three years, the annual UST Paskuhan with the theme "Pananabik, Pagbabalik, at Panunumbalik" was back on site and streamed live through the UST Tiger TV Facebook page on December 19, 2022.

The on-ground celebrations of *Paskuhan* started with the *Panunuluyan* on December 1, which is a traditional reenactment of Joseph and Mary's search for lodging right before the birth of Christ.

The following day, UST then lit its 21.5-hectare Manila campus with festive Pinoy superhero-inspired lights and decorations, including a 70-foot Christmas tree, at the Plaza Mayor. The four main drives and prominent locations within the campus, including the Main Building facade, Plaza Mayor, Benavides Monument and Park, Arch of the Centuries, Grandstand, Fountain of Knowledge and Wisdom, and the Quadricentennial Square, were lit with yellow, red, and blue energy-saving LEDs (light-emitting diodes).

This coincided with the annual UST Christmas Concert Gala, led by the Conservatory of Music, and the *Agape*, a Christmas feast.

The UST Rector Very Rev. Fr. Richard G. Ang, O.P., in his homily during the *Paskuhan* Mass on December 16, emphasized that, "Nagbabalik ang pananampalataya, ang pag-asa at ang buhay na dala ng liwanag ng Pasko. Panahon din ito ng ating pagbabalik-loob sa ating Diyos."

"Let us allow the grace of Christmas time to make us better versions of ourselves," said the Father Rector.

On December 19, the University's Christmas festivities were capped off with a much-awaited concert. Hosted by Thomasian students, the event featured guest performers and showcased homegrown Thomasian talents.

Three Thomasian bands, Sean Archer, Lucy, and Illumina, emerged as winners in the "Stellaris Unbound: *Tunog Tomasino* 2022" held on December 5. As a result, they joined the *Paskuhan* mainstage alongside guest artists, such as Mayonnaise, Adie, Lola Amour, Soapdish, Dotty's World, Kenaniah, and Earl Generao.



UST presents 15-year roadmap for the UST-Tony Tan Caktiong Innovation Center

he Jollibee Group Foundation (JGF), led by Thomasians Dr. Tony Tan Caktiong and wife Grace Ang Tan Caktiong, is an important support to UST's bid to become a major player in research and innovation and university-based entrepreneurship in Southeast Asia.

Dr. Tan Caktiong holds a BS in Chemical Engineering from the UST Faculty of Engineering, which he obtained in 1975. He also received a Doctorate in Business Administration, honoris causa, from the University. Meanwhile, Mrs. Grace Ang Tan Caktiong finished her secondary education at the UST High School and obtained her BS in Chemical Engineering degree, also in 1975, at the UST Faculty of Engineering, cum laude.

In a meeting on September 14, 2022 between the officials of the JGF and UST administrators, Prof. Philipina A. Marcelo, Ph.D. presented how the JGF-donated building will be "a venue to support the research and innovation agenda of the University by forging and sustaining longterm partnerships with industry and other external stakeholders through research commercialization, innovation, and entrepreneurship." The structure is named after the founder of the Filipino fast-food chain Jollibee Foods Corporation.

The target niche interdisciplinary research areas for UST-Sta. Rosa are

health and well-being, food security and safety, environmental sustainability, energy, information and communications, and material sciences.

"The long-term operational and sustainability plan for UST-Sta. Rosa involves three phases, namely, capacitybuilding, rapid growth, and sustained growth and expansion." Marcelo explained. "The UST-Tony Tan Caktiong Innovation Center (UST-TTCIC) will promote synergy between the University and external stakeholders to achieve the target outcomes for this plan." Marcelo, who now serves as the Assistant to the Rector for UST Sta. Rosa, said that this initial roadmap would span 15 years.

JGF executive director Ma. Gisela Tiongson attended the meeting held at the Rector's Hall at the UST Main Building. She was joined by Jenice Estrada, Caleb Uy, and Arnel Dalisay.

Empleo of Accountancy appointed to sustainability reporting committee

ST-Alfredo M. Velayo College of Accountancy Dean Prof. Patricia M. Empleo, Ph.D., was appointed as a member of the Philippine Sustainability Reporting Committee (PSRC), a committee created by the Financial and Sustainability Reporting Standards Council (FRSC).

Dean Empleo will sit as the academe representative and shall serve the committee for three years starting 2022 to

PSRC will provide technical support to the FRSC in the adoption and issuance of guidelines and standards of sustainability reporting in the Philippines.

PSRC is composed of 15 members representing the Bangko Sentral ng Pilipinas, Board of Accountancy, Securities

and Exchange Commission, Insurance Commission, Climate Change Commission, Commission on Audit, Organizations of Major Preparers of Financial Statements, and sectoral representatives from the Public Practice and the Academe.

The Financial Reporting Standards Council (FRSC) was established by the Professional Regulatory Commission under the Implementing Rules and Regulations of the Philippine Accountancy Act of 2004 to assist the Board of Accountancy in carrying out its power and function to promulgate accounting standards in the Philippines. The FRSC's main function is to establish generally accepted accounting principles in the Philippines.

CHRMS emphasizes using systematic reviews and clinical practice guidelines to inform decision-making in the healthcare industry. EBP is a crucial part of its work, as it allows research evidence to inform healthcare decisions and improve patient outcomes. CHRMS puts plans into practice for the and promotion, musculoskeletal successful delivery and evaluation of

community-engaged EBP-based interventions and seeks to integrate EBP into healthcare policies and public health settings.

The JBI supports the CHRMS-JBI Affiliated Group through training sessions and collaborations, strengthening the ability to promote EBP in the Philippines. Prof. Valentin C. Dones III, Ph.D., serves as the Director of the CHRMS-JBI Affiliated Group, and Mr. Mark Angel B. Serra is the Deputy Director. The team will advance the field of healthcare through research and consultation services.



Strong EU-PH relations discussed by Ambassador Véron at UST lecture

he Ambassador of the European Union (EU) to the Philippines, His Excellency Luc Véron, delivered the 7th Installment of the UST Ambassadors Lecture Series (ALS). With the theme "Strengthening EU-PH relations", the discussion was held at the Dr. George SK Ty Function Hall, on November 29, 2022.

In his welcome remarks, UST Secretary-General Rev. Fr. Louie R. Coronel, O.P., EHL, made mention of the participation of the University as an educational partner in the recently concluded European Higher Education Fair 2022. Fr. Coronel also underscored the previous collaborations of UST and EU—highlighting the importance of such partnerships in strengthening the internationalization thrusts of the University. This was followed by the talk of Ambassador Luc Veron.

Ambassador Véron began with a background of current relations between the EU and the Philippines, which is based on a bilateral Partnership and Cooperation Agreement, and then gave insights on key points, such as trade, good governance, maritime security, and human rights, among others.

A key highlight that he shared with the over 200 onsite student participants was on climate and the environment, where Ambassador Véron shared that as the EU commits to further cut emissions by 55% by 2030 and to become climate neutral by 2050, they will also support the Philippines and other countries in their own efforts to mitigate and to adapt to climate change.

"Climate and the environment have been one of the priorities in the EU cooperation programs with the Philippines for some time and will continue to be so in the coming years. We have been supporting the development of renewable sources of energy, the protection of biodiversity and waste management through several projects which have also aimed at providing livelihoods to poor communities. The top priority for our development cooperation with the Philippines until 2027 will be the transition to a Green Circular Economy and the support to sustainable sources of energy," said the EU Ambassador.

TOMASInno Center successfully incubates two ventures on e-learning, pain management

wo incubatees from TOMASInno Center, the University of Santo Tomas Technology Business Incubator, have successfully completed the Incubation Program and are now certified DOST- TIC Incubation graduates. Its founders joined the Graduation Ceremony on December 1, 2022, at the Dr. Robert Sy Grand Ballroom, Blessed Buenaventura Garcia Paredes, O.P. Building.

The first incubatee is Cerebro, an EdTech startup that helps solve teachers' workload issues with ready-to-use digital lessons and curriculum-aligned test banks. Having been implemented as an e-learning tool in 20+ schools during the COVID-19 pandemic, Cerebro has also been in the Top 2 of the DTI's Venture Pilipinas Startup Pitch Competition - People's Choice Awards 2021.

Cerebro was founded by its CEO Mr. Jonald Justine Itugot, a licensed professional teacher, who gained over 10 years of classroom teaching and school administration experience in different private institutions before devoting his full attention to e-learning. He is an alumnus of the UST College of Education Class of 2011.

The second incubatee is PainFree — Pain Management and Consulting, Inc., which helps people with musculoskeletal pain. Its products and services include biomechanical tape and the fasciocutaneous release techniques. It mitigates and lessens the pain of those who suffer from debilitating musculoskeletal conditions. The company has also put up a "Go PainFree" telerehabilitation platform. PainFree is founded by its CEO, the UST Center for Health Research and Movement Science Research Supervisor and College of Rehabilitation Sciences academic staff Prof. Valentin Dones III, Ph.D.

During the graduation ceremony, the keynote address was delivered by Engr. Edward Paul H. Apigo, Sr., Science Research Specialist, Research Information and Technology Transfer Division (RITTD). TOMASInno Center Assistant Manager Prof. Michael Francis D. Benjamin, Ph.D. proudly presented the graduates while Assoc. Prof. Michael Jorge N. Peralta, Executive Assistant for Intellectual Property and Research and the UST Vice Rector for



Department of Science and Technology (DOST), TIC was established in August of 2019 to assist start-ups, and to promote innovation and technopreneurship. Since its establishment, it has conducted two (2) batches of the Incubation Program with the guidance of the TIC Mentors from the Academe and Thomasian Alumni.


on the Antioxidant Activity and Phenolics of Pili (Canarium ovatum Engl.) Pomace Brew. This was a study conducted with her BS Food Technology thesis advisees namely Ma. Nicole Cybele A. Carvajal, Audrey Mae C. Lorenzo, Ana Mikaela M. Magpantay, Moira Denice B. Mirafuentes, Eunice Joy M. Molaneda, Christianne C. Reyes and Jazlyn Bon O. Yu. Together, the group found out that hot extraction of dried pili pomace resulted in greater quantities of condensed tannins, total phenolics,

flavonoids, and anthocyanins compared

to cold extraction. In addition, levels of phenolic compounds and antioxidant activity increased with increasing extraction time and temperature.

Meanwhile, her second poster titled "Pili (Canarium ovatum, Engl.) pomace in beef patties: impact on quality and acceptability", co-authored by Essence Jeanne L. Del Castillo, Kevin Rae R. Ngo and Herlyn A. Villamento, outlined part of the findings obtained from their recently completed DOST-PCHRD project. This research work highlighted the potential of pili fruit pomace as a functional incredient to minimize production costs while enhancing the nutritional and technological qualities of comminuted processed meat products such as burgers. The addition of pili pomace improved the ash, fat, protein, carbohydrates and total dietary fiber contents of beef patty and increased its total phenolic content and antioxidant activity.

Arenas is affiliated with the UST - Research Center of the Natural and Applied Sciences and The Graduate School. She is also an administrative council member of the IUFoST Early Career Scientists (ECS). ■

UST research outputs on freshwater biodiversity and ecosystems presented in national symposium

cademic and research staff and Students of the oniverse, Tomas participated during the 3rd students of the University of Santo Philippine Symposium on Freshwater Biodiversity and Ecosystem (PSFBE) held from November 9 to 11, 2022, at the Ateneo de Manila University (ADMU).

Thomasian participants presented various research works on Philippine freshwater micro- and macroinvertebrates, the feeding ecology of the endemic Sardinella tawilis of Lake Taal and methane dynamics in tropical lakes.

During the said event, Mr. John Claude Renan B. 

he University of Santo Tomas hosted the 6th Metro Manila Health Research and Development Consortium (MMHRDC) International Symposium and 13th Annual Scientific Conference at the 21st floor of the Bl. Pier Giorgio Frassati Building from November 24 to 25, 2022. The symposium was delivered in a hy-flex format; hence, virtual participants joined via Zoom.

With the theme "Post-COVID-19 Transformations and Pandemic Innovations: Rethinking Practices and Strategies for a Resilient and Healthy Juan/ Juana", the two-day symposium had for its keynote lecturer the UST Department of Biological Sciences Visiting Professor Rev. Fr. Nicanor Pier Giorgio Austriaco, O.P., Ph.D., S.Th.D.

Session 1 on Day 1 focused on Long COVID and the Complications of COVID.

Research Center for Natural and Applied Science (RCNAS) researcher and UST Hospital Medical Consultant Assoc. Prof. Ma. Rhona G. Bergantin, M.D., talked about the "Pulmonary Complications" of the said virus, while Dr. Ronald Estacio, OIC of the Philippine Heart Center -Department of Cardiology, discussed the "Cardiac Complications." Finally, Philippine General Hospital Neurologist Dr. Michelle Anlacan discussed the "Neurological Complications" related to Long COVID.

Session 2 (Day 1) highlighted "Engineering Innovations During the Pandemic". The UST Faculty of Engineering

Dean and RCNAS researcher Prof. Angelo R. Dela Cruz, Ph.D., served as lecturer.

On Session 3 (Day 1), MMHRDC Director Prof. Hilton Y. Lam, Ph.D., discussed the "National Pandemic Response Playbook", while Dr. Myra Villareal, a DOST-Balik Scientist and a faculty member of University of Tsukuba - Life and Environmental Sciences Department, shared some nutritional tips in her lecture on "Functional Foods for COVID-19 Infection. DOST-Philippine Council for Health Research and Development Executive Director Dr. Jaime Montoya, Ph.D., talked about "International Collaboration in the COVID-19 Pandemic".

"Interprofessional Education" was the focus of Session 4. Dr. Erlyn Sana, Chair of the Office of Research and Development of the National Teacher Training Center for the Health Professions - University of the Philippines - Manila, served as the resource speaker.

Adamson University - Junior High School Principal Mr. Daniel B. Saroca, Jr., Ph.D., talked about the challenges of learning at the Elementary and Junior High School level, while Commission On Higher Education – Assistant Chief Dr. Liza Magana spoke about the concerns at the collegiate level for Session 5, which centers on "Challenges in Education and Health During the Pandemic". In the same session, the UST Faculty of Medicine and Surgery Dean Asst. Prof. Lourdes Maglinao, M.D., MHPEd, tackled "Medical and Paramedical Education".

Day 2 opened with Session 6, with the topic "Ethical Issues and Changes in Research During the COVID Pandemic". DOST-Balik Scientist and UST Faculty of Medicine and Surgery Visiting Professor Fidela L. Moreno, M.D., was the lecturer.

"Trends in Postgraduate Training in Health Sciences" became the focus of Session 7, with Dr. Steve Milanese, Director of the International Center for Allied Health Evidence and a Visiting Professor, discussing "PhD in Health Sciences: By Research/Scoping Review." After that, Dr. Craig Lockwood of the University of Adelaide - Faculty of Health and Medical Sciences tackled "MS in Implementation Science", while Dr. Nadine Jose of the Rutgers University talked about "MS in Clinical Trials".

Research paper presentations followed after the sessions in two breakout rooms. As of 2022, MMHRDC has 44 member institutions composed of 20 academic institutions, 9 medical centers and government and non-government agencies (private, NGOs, professional society). Over the years, MMHRDC has provided Basic Research Training to young and budding health researchers; facilitated the provision of research funding: showcased research, including lectures and research posters; capacitated institutions to attain PHREB accreditation; hosted scientific conventions and fora that allowed Filipino researchers and students to learn and interact with other researchers and scientist in the health research community.

UST Sentro sa Salin conducts lecture on liturgical translation

ST Sentro sa Salin at Araling Salin helped spearhead the webinar "Ang Papel ng Liturhiya at Pagsasalin sa Pagpapaunlad ng Pamayanan" via Zoom on November 5, 2022.

The webinar was initiated by the heads of Latin Liturgical Translation course under the Master of Arts in Liturgy Program of San Beda University, in collaboration with the UST Simbahayan Community Development Office.

In her opening remarks, UST Sentro sa Salin Chair Dr. Wennielyn Fajilan looked back at the training given to the Latin Liturgical Translation class last year, which confirmed that students who specialize in liturgy and doctrine have a great potential to become translators because they are subject matter experts.

Asst. Prof. Alvin Ringgo C. Reyes lectured on "Batayang Teorya sa Pagsasalin," underscoring the contribution of translation to the expansion and propagation of knowledge, aside from intercultural understanding between two different ethnic communities. The Secretary of National Committee on Language and Translation of the National Commission for Culture and the Arts (NCLT-NCCA) also mentioned translation scholars, including Friedrich Schleiermacher, Lawrence Venuti, Eugene Nida, and Peter Newmark.

UST Vice Rector for Finance Rev. Fr. Roberto Luanzon Jr., O.P., S.Th.D., DL, who also teaches at the Graduate School of Liturgy of San Beda University, discussed "Mga Prinsipyo at Konsepto ng Pagsasaling Panliturhiya," which summarized Pope Paul VI's message and instruction to translators of the liturgy.

He explained that aside from Latin, translations in the vernacular languages are considered as official languages of

liturgical worship of the Roman Catholic Church. However, the level of communication should be separate from the language of the street and public markets, since it has to be worthy of the dignified reality it represents in the liturgy.

In his lecture "Wika at/sa Pagbubuo at Pagpapaunlad ng Pamayanan," UST Simbahayan Community Development Office Director Asst. Prof. Froilan Alipao, MCD pointed out that "pagpapaunlad ng pamayanan" (community development) developed from being Western into a discipline that is "katutubo, Pilipino, maka-bayan, at maka-tao" (indigenous, Filipino, nationalistic, and humanist).

The webinar was live-streamed via the UST Sentro sa Salin's official Facebook page, so more individuals will learn about the mutual goals of church, academia, and local communities in cultivating effective communication and stimulating teaching practice, research, and development in communities.

tolerance, human rights, and sustainable development. As the world emerges from the Covid-19 crisis, the Summit has provided an opportunity to mobilize greater commitment, and action for SDG 4 (Quality Education), reimagine education, and accelerate progress on education and the 2030 Agenda more broadly for the remainder of the Decade of Action.

Discussions generated recommendations for the subregion to go forward in terms of priority actions and implementation strategies from the perspective of system transformation and building resilience and improving learning for accelerating progress towards SDG 4.

Lectures and Conferences

Renowned parasitologists discuss parasitic infection insights at UST Pharmacy seminar

he Faculty of Pharmacy Department of Medical Technology sponsored a CPD seminar through its regular *Discurso* on November 10, 2022. This seminar titled "Facts of Fascioliasis: Trailblazing research on Liver Fluke Infections" was held at the Central Laboratory auditorium. Two notable parasitologists from the University of Valencia, Spain, were invited to provide updates and insights into emerging public problems with zoonotic origin.

The first speaker was Prof. Dr. Santiago Mas-Coma, an expert member of the World Health Organization. He discussed Human and Animal Fascioliasis with emphasis on parasite morphology, distribution, epidemiology, modes of transmission, and public health impact. He also stressed the existence of intermediate forms of *Fasciola* sp., a new focus for research that institutes future challenges in the control and prevention of this parasitic infection from a worldwide perspective.

The second speaker, Prof. Dr. Maria Dolores Bargues Castello, is the deputy director of the World Health Organization Collaborating Center on Fascioliasis and its Snail Vectors. Her talk dealt with the relative importance of snail vectors in the transmission of Fasciola sp. and Schistosoma sp. She described freshwater gastropods, especially those belonging to the Family Lymnaeidae, in terms of their morphology, relative abundance, and phylogeny. She also shared her experiences

with human schistosomiasis across the globe. Both of these parasitic infections, fascioliasis, and schistosomiasis, are zoonotic and are common in the Philippines.





he Catholic Bishops' Conference of the Philippines (CBCP) Episcopal Commission on Indigenous People (ECIP) Consultation Meeting organized by the University of Santo Tomas IPA-IP, in collaboration with the UST Graduate School Center for Conservation of Cultural Property and Environment in the Tropics (GS-CCCPET) was held at the UST BI. Pier Giorgio Frassati Building on September 20, 2022.

The meeting provided a forum for indigenous representatives to discuss current challenges and issues confronting their respective communities. Furthermore, it focused on exploring areas of concern that could serve as a guide for creating a tailored-fit approach that will assist these indigenous communities in achieving their own vision of development.

Critical concerns relating to indigenous communities served as themes in the National Assembly of the CBCP-ECIP Network in November 2022, which was attended by twenty representatives including Bishop Valentin Dimoc, D.D., Chair of the CBCP-ECIP and Bishop of the Prelature of Lagawe; Mr. Tony Abuso, Secretary-General of the CBCP-ECIP; Fr. Renerio Sabuga of Cagayan de Oro; Fr. Gabby Oybad of Mangyan Mission- Calapan, Oriental Mindoro; Pablito Gonzales of Diocese of Kabankalan, Negros Occidental; Mr. Jose Paje of Gingoog City, Misamis Oriental; and Mr. Jonathan Camanso of Negros Occidental.

he UST Medicine Class of 1981 celebrated their 40th anniversary through an exhibition of their own artworks in various media. More than forty years have transpired since the graduates of UST Medicine Class 1981 left the portals of UST. Some chose to stay but a number became part of the medical diaspora, each seeking his own place in various fields of medicine. After spending most of their productive professional lives in intense academic and clinical work, this time, either retired or nearing retirement, the members of the class return to a lost love: ART.

By rekindling their interest in art, they

became young again, playing with shapes and colors. By drawing and painting, they rediscovered a part of themselves that was buried and overtaken by the rigors of medical training and practice. For them, it was like breathing a new kind of air and being filled with a sense of awe and wonder in their late years.

"In the play of art we regain the wit and the courage to deal with the harshness or dullness of daily life. We turn to art. not to escape but to allow the mind to rest, to release the inner spirit of intuition in play, and thus find our way through our dark labyrinths," renowned Filipino poet Merlie Alunan once said.

It is in this spirit that the Magilas Art Group was formed during the time of the COVID-19 pandemic. After more than a year of learning from each other and sharing their experiences and challenges in painting and drawing online, the class

agreed to celebrate its Ruby anniversary by mounting an exhibition, not only to feature their artworks, but to raise funds for the benefit of the indigent patients needing surgery at the UST Hospital Clinical Division as well.



Its new releases became available at discounted prices, beginning with the latest creative nonfiction titles in its shelves: "Easy Listening," a collection of personal musings from veteran journalist Nestor Cuartero on culture, the arts, and the pleasures of the quotidian; and "From Manila to the World," which unfolds Paolo Mangahas' adventures in 10 different locations, through the author's thoughtful and authentic voice.


Coming soon in fiction is "Kathang Haka: The Big Book of Fake News," an anthology of short fiction edited by Dean Francis Alfar, Nikki Alfar, and Louie Jon A. Sanchez, which imaginatively responds to the perversions of truth in contemporary Philippine society through storytelling.

Latest in the nonfiction category is "Honora Medicum: 150 Years of the UST Faculty of Medicine and Surgery, the First School of Medicine in the Philippines," the UST FMS 150 commemorative book, which is meant to celebrate the "mother" of all medical schools in the country, to pay tribute to the 50,000 UST doctors and their extraordinary impact on society and honor the generations of doctor-teachers.

In the Theology and Philosophy category, the USTPH has released "Faith and Reason in the Catholic Intellectual Tradition" by Joel C. Sagut, which ruminates on the tensions between faith and reason, and their ultimate mutuality in Catholic thought. Renowned Filipino scholar Alfredo P. Co's new work, "Doing Philosophy in the Philippines: The Thomasian Collection (1951-1959) Volume II," was also recently released and launched alongside its first volume, which both collect scholarly articles on the condition of Filipino philosophy, and the trajectories of humanistic thought in the Catholic intellectual tradition. Joining them is "Faith and Psychology: A Walk-Through on the Filipino Basic Ecclesial Communities" by Milagros C. Arrevillaga, a close look into Philippine ecclesial communities and the psychology of communal living rooted in faith.

Esteemed fictionist Cecilia Manguerra Brainard is set to release the collection "Growing Up Filipino 3: New Stories for Young Adults," the third in a series of short fiction which tackles the unique yet universal experience of childhood and its reiterations in memory, craft, and Filipino culture.

Also coming soon on the bookstore's shelves are the following anthologies: "Bayan-Bayanan: Antolohiya ng mga Katha sa Lunan ng Gunita," edited by Rolando B. Tolentino and Rommel B. Rodriguez, which gathers short stories on home, land, and origin, and their inextricable link to memory and personhood; and two creative nonfiction titles, "Aruga: Mga Sanaysay ng Pagtanggap at Paglingap," co-edited by Rodriguez with



Ferdinand Pisigan Jarin, a collection of personal essays that draw from the unique articulations of "care" in Filipino culture; and "The Lives of a Filipino/a High School Student: Anthology of Personal Essays on High School in the Philippines," (which Jarin co-edited with Rolando B. Tolentino and Joselito De Los Reyes) providing an intimate look into the Filipino high school experience, one that is marked by explorations and transformations on relationships and identity, contextualized within the country's tumultuous educational and social condition.

Finally, master musicologist and UST Research Center for Culture, Arts, and the Humanities (RCCAH) Director Maria Alexandra Chua will soon release "Julio Nakpil Collected Works Volume I: Piano, Vocal, and Chamber Music," a landmark work that compiles the extant music of renowned Filipino composer, Julio Nakpil, including some of his earliest musical pieces that were printed, published, and circulated in the late nineteenth-century Spanish colonial Manila.

These new and upcoming titles were available for the first time during the USTPH annual Christmas Book Sale. They are available at the UST Bookstore and its online bookstores at Shopee and Lazada


he University of Santo Tomas Graduate School Center for Conservation of Cultural Property and Environment in the Tropics (CCCPET) traveled to Lingayen, Pangasinan to attend a consultative meeting arranged by Provincial Governor Ramon "Mon-Mon" Velicaria Guico, III. The objective was to further discuss the cultural heritage conservation and management program that is being directed by Assoc. Prof. Eric Zerrudo, Ph.D., Director of CCCPET, in partnership with Urban Planner and Architect Paulo Alcazaren.

The cultural heritage conservation and management program is a set of composite projects across Pangasinan province. At the moment, CCCPET has initiated the development of *Bana'an*: The Provincial Museum of Pangasinan in Lingayen and the Binalonan Municipal Museum. The initial projects were complemented by the following: Site Development of Casa Real Grounds, Conservation Management Plan and Adaptive Reuse Plan of Pangasiinan Provincial Jail, Bengzon-Yuson House Adaptive Reuse Plan, and Conservation Management Plan of Pangasinan Capitol Building.

The meeting provided an opportunity for all CCCPET team members to present their plans and to share valuable insights on the preparation, planning, implementation and completion of the aforementioned projects. Also included in the visit was the conduct of an ocular survey to the different areas. The engagement was facilitated by the Pangasinan Tourism and Cultural Affairs Office headed by Ms. Malu Elduayan, Provincial Tourism Officer.

Guico, along with other key stakeholders, expressed their optimism and shared their visions for the province of Pangasinan. His vision of a cultural revolution for the province was valuably supported and taken as a development agenda by the CCCPET team.

culinary competitions to the students.





and 4) Math in the Modern World at the College of Science. She described these SL courses as exploratory, transformative, social constructivist, and research-based.




