UST inaugurates Tony Tan Caktiong Innovation Center at its Santa Rosa campus

The University of Santo Tomas held the solemn blessing and formal inauguration of the UST-Tony Tan Caktiong Innovation Center (UST-TTCIC) at its 40-hectare campus in Santa Rosa City, Laguna. The rites coincided with UST's 412th foundation anniversary on April 28, 2023.

The innovation center is named after its donor Dr. Tony Tan Caktiong, Chairman and Founder of Jollibee Foods Corporation (JFC). Tan Caktiong graduated from the UST in 1975 with a Bachelor of Science in Chemical Engineering. He also received a Doctorate in Business Administration, *honoris causa*, from UST in 2018.

In his message, Tan Caktiong expressed his joy over the completion and inauguration of the innovation center and its significance to the UST community, as well as to the future of the Philippines.

"This state-of-the-art innovation center in the midst of the UST community is intended to champion innovation and entrepreneurship with its end in mind to benefit not only the University, but also the country and society as a whole," Tan Caktiong said. "This Center can serve as a catalyst for promoting innovation that fosters connection, empathy, and compassion, and I am very excited to see the impact it can have on many people's lives and well-being."

Innovation for a better future

Tan Caktiong has always been passionate about innovation and continuous learning, evident in how he steered JFC from a single-brand company into one of the world's largest restaurant companies with 16 brands operating over 6,500 stores across 34 countries.

"I am very thrilled of how this Center perfectly aligns with my ardent belief in the incessant thirst for continuous learning and dreaming big, all the more so as the pace of change in the world is increasingly becoming more rapid," he said. "Being unable to adapt can put in question one's relevance and render

As we build back better from the pandemic, this Center is in a remarkable position to harness the power of science and entrepreneurship in developing products and processes that can promote food security and improve livelihoods, especially in the rural areas."

Partnership for nation-building

UST Rector Very Rev. Fr. Richard G. Ang, O.P., Ph.D., in his message, shared that "The UST-TTCIC is designed to foster creativity and collaboration. It will be a place for researchers, innovators, and entrepreneurs to exchange ideas, share knowledge and work together towards a common goal-creating a better future. The various laboratories, workshops, and workspaces in this building have been carefully planned to support a wide range of research and innovation activities, whether you're a scientist working on a breakthrough discovery, an engineer developing a new technology, or an entrepreneur launching a startup, this Center will provide you with the resources and support that our stakeholders need to succeed."

UST Facilities Management Office Director Rev. Fr. Dexter Austria, O.P., shared that "The edifice we are inaugurating today is the first among many in the pipeline, hoping that this campus becomes as it is envisioned–a research complex, a visible testament of UST's indomitable pursuit of making research a cornerstone element, a building block in the field of education."

The event included a Eucharistic Celebration and Entrustment to the Blessed Virgin Mary led by UST Vice Rector for Religious Affairs Rev. Fr. Pablo T. Tiong, O.P., the ribbon cutting, and the solemn blessing rites.

In September 2022, UST laid down its 15-year road map for the Center. On the same occasion, the Assistant to the Rector for UST Santa Rosa Prof. Philipina Marcelo, Ph.D., presented the three phases of UST Santa Rosa's long-term operational and sustainability plan. She mentioned that UST Santa Rosa will target health and well-being, food security and safety, environmental sustainability, energy, information and communications, and material sciences as its interdisciplinary research areas.

"The Innovation Center is a tangible manifestation of our shared commitment, common values, and vision. We get an opportunity to nurture the next generation of leaders, thinkers, and entrepreneurs, and in so doing, we will continue to shape the future of our country," Tan Caktiong said of the partnership with UST.

The UST-TTCIC held its groundbreaking ceremony in December 2020, while the UST Santa Rosa campus had its site development kick-off ceremony in September 2017. The construction is led by Casas+ Architects, Mundo Builders, Design Coordinates, Inc., and the UST Facilities Management Office. ■

The University, through the efforts of the UST Miguel de Benavides Library and Faculty of Civil Law entered into a partnership to digitize the UST Law Review, the official journal published by the Faculty of Civil Law. The journal is a student-edited publication that includes articles by law professors, members of the judiciary, and students of the Faculty, as well as commentaries, case summaries, legislations, and book reviews. The signing of the Memorandum of Agreement (MoA) between Atty. Nilo T. Divina, Ll.B., Dean of the Faculty of Civil Law and UST Rector Rev. Fr. Richard G. Ang, O.P., Ph.D., was held at the DivinaLaw Hall on March 31, 2023.

Witnessing the MoA signing were the Prefect of Libraries Rev. Fr. Ángel Aparicio O.P.; Assistant to the Prefect of Libraries Rev. Fr. Gaspar R. Sigaya, O.P.; Chief Librarian Ms. Maria Cecilia D. Lobo; Regent of the Faculty of Civil Law Rev. Fr. Isidro C. Abaño, O.P.; UST librarians, Law Review editorial team, and partners and associates of DivinaLaw.

For the digitization project, the agreement stipulates that the donation shall cover the expenses of hiring additional staff who will work on the scanning of the journal's copies dated 1950 up to the present. For its part, the Library will supervise and monitor the scanning, conversion, and uploading of the digitized copies of the journal to the UST Digital Library.

This significant collaboration will allow more comprehensive access to numerous law information and preserve noteworthy research and scholarly discourses that will help improve legal education in the country.

Award for her outstanding contribution in research and teaching in the field of Operations Research and for her service to the Industrial Engineering and Operation Management profession while Ngo received the IEOM Society Outstanding Service Award for her outstanding achievements, contributions, and service in the same field.

The IOEM Society International. a global organization dedicated to the advancement of industrial engineering and operation management discipline, recognizes educators, researchers, and

other professionals for their significant contribution through teaching, research and publication, service, innovation, or leadership in the field of engineering and operations management.

Mabini was Dean of the UST Faculty of Engineering from 2000 to 2006 and served as academic staff of the UST Department of Industrial Engineering until her retirement. She was also resident researcher in the UST Research Center for Natural and Applied Sciences (RCNAS) and served as administrator in various capacities in the university. Her many

achievements include recognition from the Philippine Regulatory Board (PRC) for her contribution to the growth of the academic sector of the country as well as serving as a role model in the IE profession, from the Philippine Institute of Industrial Engineers (PIIE) for her dedicated service and invaluable contribution as a member of Board of Trustees of the Industrial Engineering Certification Board, and "Inspiring Filipina Engineer" from the Philippine Technological Council - Women Engineer Network (PTC-WEN).

Ngo was Chair of the UST Industrial Engineering Department from 1991 to 2000. 2002 to 2005, and from 2019 to 2022. She was one of the prime movers in the successful implementation of Total Quality Management (TQM) which earned the University the Philippine Quality Award (PQA) Level 2 recognition. She was also Director for Quality Management Office (QMO) and was the Quality Management Representative of the University from 2013 to 2018. She is also a founding member of the Philippine Institute of Industrial Engineers (PIIE) and a Board of Trustees of Philippine Technological Council – Women Engineers Network (PTC-WEN).

Caliwan of Accountancy is named next NACPAE President

ST-AMV College of Accountancy Assistant Dean Mr. Francisco M. Caliwan, Jr., was elected as the next President of the National Association of CPAs in Education. The election happened during the 30th Accounting Teachers Conference held at the Villa Caceres Hotel, Naga City, from April 26 to 28, 2023.

Caliwan vowed to create projects that would improve the delivery of accountancy education in the Philippines. He promised to establish focused groups that will study the declining passing rate of the Licensure Examination of CPA (LECPA); review the alignment of the senior high school curriculum, the BSA curriculum, the LECPA syllabi, and the competency requirements for entry-level CPAs; and design a model internship program for accounting students and immersion program for accounting teachers. He also pledged to spearhead a series of dialogues between the accountancy regulators and accountancy school administrators to establish open and constant communications between the different stakeholders of the accounting practice in the Philippines. Moreover, he swore to decentralize the operations of the association by constituting NACPAE regional chapters.

Caliwan's presidency will start on July 1, 2023 and will end on June 30, 2024. He will be the NACPAE's 33rd president.

Rawls," "US-Taiwan-China Relations," "Bibliometry of IDAS student researchers." and "Australia and the Asia-Pacific." respectively.

The discussions provided insightful debates about geopolitics, incorporating both liberal and realist perspectives on conflict resolution and peace studies.

CTHM academic staff, students bring home research awards from PARTH

THM academic staff and students joined the 8th Tourism and Hospitality Annual Research Convention (THARC) and the 9th Annual Tourism and Hospitality Student Research Conference (ATHSRC) 2023, organized by the Philippine Association of Researchers for Tourism and Hospitality, Inc. (PARTH). It was held from April 19 to 21, 2023.

Out of 33 manuscripts from faculty and graduate students, Ms. Lizette A. Vicente, academic staff from the Department of Tourism Management and a candidate for Ph.D. in Human Resource Management of the Graduate School, won Best Paper for her research titled "Perspective of Laid off Employees toward Retrenchment and Outplacement Programs of Selected Airline Companies in the Philippines: An Outplacement Framework Proposal."

The research aimed to determine the importance of retrenchment and outplacement programs to the voluntary and involuntary laid off employees of two airlines. The study showed that a retrenchment package, employee assistance, financial assistance, and psychological assistance are essential in the termination of employment. The research's contribution to the existing literature provides a methodology for integrating specific outplacement programs as part of the human resource programs of the organization. Accordingly, the implementation of the proposed outplacement framework can assist the organization on how to better manage the laid off employees affected by the crisis and incorporate it as part of the organization's development.

they address the question, "How best can universities engage communities in a mutually respectful and equal partnership to advance public health education?".

With the current opportunities and threats for the proper use or misuse of AI, especially in its novel capacity for creativity in manipulating vast amounts of data, the lecture has clarified a lot of critical issues and is in line with the United Nations Sustainable Development

GS Nursing webinar examines implications of Al on healthcare

he webinar "Artificial Intelligence and Universal Health Care: Will the Twain ever meet?" was conducted via Zoom and Facebook Live on April 28, 2023. More than 100 students, academic staff of different universities, nurses, doctors, and other members of different healthcare institutions participated in the webinar organized by the Current Trends and Issues in Nursing and Healthcare class of the UST Graduate School.

Artificial Intelligence (AI) is currently a contentious topic as it continues to advance technological innovation. Its implications for the Philippine healthcare system and its impact on healthcare professions are issues worth investigating. Meanwhile, ensuring health equity through Universal Health Care is another pressing concern. Although these two concepts may seem contradictory, they have both left their mark on the healthcare industry. As a result, the webinar examined the potential for these seemingly opposing ideas to intersect and find common ground.

Prof. Rowena Escolar-Chua, Ph.D., the Program Lead of the Nursing and Hospital Administration Master's programs and Dean of the UST College of Nursing, delivered the welcome remarks.

The resource speaker was Prof. Annabelle R. Borromeo, Ph.D., the current Chief Nursing Officer of Metro Pacific Health, the largest group of private hospitals and other healthcare facilities in the Philippines. She was awarded by the Professional Regulation Commission as 2022 Outstanding Professional in Nursing and has worked in the areas of patient experience and patient safety for more than 20 years.

Borromeo highlighted that the healthcare industry is currently in the early stages of adopting AI technology. She provided insights on the potential applications of AI in healthcare, before transitioning to the topic of Universal Health Care. She provided an overview of the system, its coverage, and how individuals can avail themselves of it in order to achieve the best possible outcomes for the health



system's building blocks, action domains, and outcomes, including quality, efficiency, equity, accountability, sustainability, and resilience. She argued that data management using Artificial Intelligence would be key.

The discussion concluded with an examination of how Aldriven tools could help achieve the best possible outcomes for the Universal Health Care system and its impact on healthcare in the Philippines.

Course facilitator Dr. Teresita I. Barcelo, in her closing remarks, mentioned that there is a place for Artificial Intelligence but it should not replace people, and that ethics in the use of AI must be at its core.

The webinar attendees gave impressions and feedback that they learned how AI can help our healthcare delivery systems such as our Universal Health Care with proper technical balance and ethical consideration and regulation.

he Vibal Foundation, in partnership with the University of Santo Tomas Miguel de Benavides Library launched the "Imprenta Ramirez y Giraudier: A Story of Late Nineteenth-Century Philippine Intellectuality," which was written by historian Lino L. Dizon, Ph.D. The event was held on March 29, 2023, at the ground floor of the UST Miguel de Benavides Library.

Imprenta details the establishment of the influential publishing firm Imprenta Ramírez y Giraudier (IRG) and how it became one of the crucial engines of Spanish-speaking society in the Philippines during the late nineteenth-century.

Founded by Don Manuel Ramírez y Carvajal and Baltazar Giraudier y Ortega, IRG's newspapers, novels, magazines, and journals paved the way for the birth of important social movements such as the development of the Ilustrado class, the Propaganda movement, and the Philippine Revolution.

The launch was attended by the Philippine Ambassador to Austria Evangelina Lourdes Arroyo-Bernas; Chairman of the Board of Commissioners of the National Commission for Culture and the Arts (NCCA) Dr. Victorino Manalo; Director General of the National Museum of the Philippines Mr. Jeremy Barns; National Library of the Philippines Director Mr. Cesar Gilbert Adriano; National Historical Commission of the Philippines (NHCP) Chairman of the Board Dr. Emmanuel Calairo, and NHCP Board Members Dr. Rene Escalante, Dr. Earl Jude Cleofe, and Dr. Lisa Guerrero Nakpil. **UST LIBRARY LAUNCH BOOK TO PAGE 16**

While this largest regional FTA in the world promotes mechanisms and strategies for addressing the emerging trade issues affecting small and medium enterprises (SMEs). e-commerce. competition. intellectual property, and government procurement that were not covered in existing FTAs, the recent trends, developments, and challenges of Philippine traders and SMEs would forecast the future of our operational competitiveness and sustainability against the rest of the world.

According to Fr. Aparicio, these publications nurture the inquisitive minds of those who became fathers of the land. He also said that it is the sacred duty of those engaged in publication and research to preserve the precious heritage and make it accessible to each one interested in culture and spur the hearts of those who have a say in promoting culture in the country.

In his welcome message. Fr. Aparicio

National Historical Commission of the Philippines (NHCP) Chairman of the Board Dr. Emmanuel Calairo said in his message that the press played a significant role in the intellectual enlightenment that led to the *llustrado* movement in the 19thcentury Philippines. During this period, the publishing firm Imprenta de Ramírez y *Giraudier* was one of the first lithographic presses, which paved the rise of various printed materials and further became the venue of Filipino-Spanish intellectuals who echoed Filipino sentiments for reform and independence. Significantly, to understand the history of the printing press, the author presented different viewpoints to understand the history of the printing press in the Philippines. Furthermore, Calairo said that this book would add to the growing number of references on the subject matter and the firm produced various publications,

including influential periodicals, and will serve as the foundation for the modern field of Philippine studies.

Vibal, in the Publisher's Message, introduced the book as the dream project of Dizon, which has come to completion as the remarkable renaissance and translation of the mid to late nineteenth-century Spanish-Philippine intellectuality. He added that this book joins the rostrum of books that investigate Philippine intellectuality, including national artists, propagandists and Ilustrados.

Vibal also encouraged everyone to examine UST's special exhibition. Mounted were special IRG rarities, exhibited for public display. The brochures contain QR codes that can be scanned on mobile phones and could be easily flipped to examine these forgotten books as living artifacts.

Dizon said that the project focuses on the production of knowledge and intellectual development of the period through the Imprenta de Ramirez y Giraudier, and this is a topic that Vibal Foundation and himself believed is very much lacking and wanting in Philippine colonial scholarship.

The highlight of the program is the presentation of the first copies to the selected distinguished recipients.

Part of the activity was the awarding of the token of appreciation to Ambassador Arroyo-Bernas by the UST Library administrators together with the Secretary-General Rev. Fr. Louie R. Coronel, O.P., EHL.
