The University, through the Faculty of Civil Law, in coordination with the Central Committee on University Events, announces the **Conferment Rites for the *Juris Doctor* degree<sup>1</sup>** among graduates of the Bachelor of Laws program for the Classes of 2018 and earlier. The event will be held at the **Quadricentennial Pavilion** on **29 July 2023 (Saturday), 4:00 pm to 9:00 pm** and is expected to be participated in by around 1000 alumni. To ensure a smooth flow of traffic inside the campus, below are access points and parking spaces (*See also attachment*):

### I. Entrance and Exit Gates for Pedestrians and Vehicles

#### 1. Faculty of Civil Law alumni

- Gate 1 (España Boulevard) – entrance and exit for pedestrian;
- Gate 4 (España Boulevard) – entrance and exit for vehicles;
- Gate 7 (P. Noval St.) – entrance and exit for pedestrian, exit for vehicles;
- Gate 14 (Lacson Gate) – entrance and exit for pedestrian and vehicles;
- Gate 10 (Dapitan St.) – entrance for pedestrian and vehicles;
- Gate 11 (Dapitan St.) – entrance and exit for pedestrian; exit for vehicles.


#### 2. Parishioners and Visitors

- Gate 7 (P. Noval St.) – entrance and exit for pedestrians visiting the UST Parish (i.e., Parishioners);
- Gate 14 (A.H. Lacson Ave.) – entrance and exit for pedestrians; entrance and exit for vehicles visiting UST Hospital; and entrance for vehicles visiting the Santísimo Rosario Parish.

### II. Parking Spaces

- The participating alumni are encouraged to do carpooling.
- On a first-come, first-served basis, they will be assisted to park at available parking spaces on campus. They may also be advised to use the multideck car park.
