UST-Science lecture features chemistry applications in treating cancer, mental disorders

he University of Santo Tomas College of Science hosted the Distinguished Alumni Lecture in Chemistry that highlighted the application of chemistry in cancer and mental health research. The lecture was held on August 11, 2023 at the Central Laboratory Auditorium.

Dr. Meden Isaac-Lam, currently an Associate Professor at Purdue University in Northwest Indiana, USA, and an alumna of the UST BS Chemistry (Class of 1980) served as the esteemed speaker. Her captivating talk delved into the significance of chemistry in treating cancer and mental disorders.

Lam's talk, titled "Chemistry Applications in Cancer and in Mental Disorder," presented pioneering research that promises advances in two critical areas. Her lecture highlighted the synthesis of photosensitizers for potential use in photodynamic therapy (PDT). These synthesized compounds show promise in combating triplenegative breast and prostate cancers.

In addition, Lam discussed the application of chemistry in understanding

post-traumatic stress disorder (PTSD), a mental health concern for American military personnel. Her innovative use of magnetic resonance imaging and spectroscopy (MRI/MRS) revealed metabolic imbalances in specific brain regions of individuals with PTSD, shedding light on potential correlations between neurometabolites and the disorder's severity.

The lecture, co-sponsored by the UST Department of Chemistry, the Research Center for the Natural and Applied Sciences (RCNAS), and the UST Graduate School, drew an audience composed of BS Chemistry students, academic staff of the College of Science, researchers from RCNAS, and graduate students from the UST Graduate School.

The event served as a platform for highlighting the significant contribution of chemistry in addressing diverse health concerns. Additionally, it demonstrated the University's dedication to promoting academic and scientific excellence through joint initiatives and by engaging notable alumni who have excelled in their chosen fields.

CTHM students bring home prizes from THE-ICE Global Revenue Management Challenge 2023

nna Mae Pano and Justin Bryle V. James, BS Hospitality Management students from the College of Tourism and Hospitality Management, were included in the interschool teams who won 1st and 3rd Place, respectively, during the International Centre of Excellence in Tourism and Hospitality Education (THE-ICE) Global Revenue Management Challenge 2023.

The competition unites students and academic staff across the THE-ICE network into teams in an innovative and exciting format that will test and develop their hospitality and tourism revenue management skills. Students are teamed up with others worldwide to increase international collaboration, share knowledge, and enhance team working. Each team has four or six students from two or three institutions. THE-ICE organizes the competition with Russell Partnership Technology and STR SHARE Center.

Gozum, Gutierrez of IR publish new studies on proposed pastoral program

Pastoral Response to the Increase in the Number of Suicide Cases in the Philippines During the COVID-19 Pandemic" was published in a Q1 Scopus-indexed journal, *Journal of Religion and Health*. The article was co-authored by Institute of Religion academic staff members Mr. Ivan Efreaim A. Gozum and Asst. Prof. Joselito G. Gutierrez, Ph.D., who are also affiliated with the Center for Theology Religious Studies and Ethics.

In the paper, Gozum and Gutierrez explored the reports and statistics concerning the increase in suicide-related cases during the height of the COVID-19 pandemic. Though there were already known cases before the onset of the pandemic, some experts believe the pandemic contributed to the increase in the number of cases and may have produced added stressors that affected mental health. These include domestic conflicts and violence, financial loss, anxiety and depression, and pre-existing mental health conditions as factors in the spike in suicide cases.

Furthermore, the authors underscored the Church's commitment to promote the sanctity of life in the midst of the health crisis. Different social issues that concern taking one's life, or even degrading one's value are addressed by the Church to uphold the inherent dignity of all persons. At the same time, it continues to update itself to respond to new challenges, including the problem of mental health.

Moreover, considering that access to basic health care in the Philippines is limited, the authors highlight that the Church and other sectors are encouraged to develop appropriate programs to assist individuals affected by the pandemic. In line with this, Gozum and Gutierrez proposed a pastoral program that includes a prevention, intervention, and postvention plan.

The proposed pastoral program was inspired by the Pastoral Letter on Suicide written by the Thomasian Cardinal, His Eminence Most Rev. José F. Advincula Jr., D.D., who highlighted the "culture of presence" in the community. This program encourages collaboration among Church leaders and lay professionals who can assist in giving support to people involved in suicide-related cases.

The program also suggests that the Church can provide support groups and counseling services to create a safe



environment for sharing experiences and healing together for persons who have attempted suicide or have family members who attempted or died as a result of suicide. Church leaders must implement emergency response protocols, which include measures for alerting emergency services, offering urgent assistance, and assuring the safety of the individual in danger. This step can only be completed if the Church and mental health specialists work together effectively. Individuals in crises might also benefit from parish prayer groups and receive spiritual advice and direction. The Church must also focus on the spiritual well-being of the members in order for them to experience a loving community, as indicated in the prevention

The article adds to the growing literature on mental health studies since it provides an intersection between faith and science. The authors show that the Church can be of great help in the ongoing global concern on mental health.

Espino of CRS presents biomechanics research at int'l conference in Thailand



sst. Prof. Reil Vinard Espino, an academic staff from the College of Rehabilitation Sciences in the Sports Science Department and a doctoral candidate in Health Research at the UST Graduate School, presented his research titled "Biomechanical Parameters Assessed During Running Among Running-Related Athletes with Recurrent Hamstring Strain Injury: A Scoping Review." He shared his work at the 9th Asian Society for Sport Biomechanics (ASSB) and 2nd Sports Authority of Thailand (SAT) International Conference on Sports Science titled "Sports Biomechanics: From Research to the Field." The conference was held from August 28 to September 1, 2023 at the Grand Four Wings Hotel in Bangkok, Thailand.

Espino's study aimed to provide an overview of the essential biomechanical parameters that have been evaluated in running-related athletes with recurrent hamstring strain injuries (HSI) and outline the common testing procedures used to assess these parameters in this specific athlete population.

During the same conference, he was selected to serve as member of the board of directors for the ASSB for the term 2023-2024.

The primary objective of the conference was to facilitate the integration of sports biomechanics research into practical applications and create opportunities for research collaborations with other Asian universities in the field of Sports Biomechanics.

The conference drew participants from all over the globe, including undergraduate and graduate students, academics, and sports biomechanics experts. The event featured keynote speeches and practical presentations, alongside oral and poster research presentations from a diverse array of institutions. Various companies from around the world showcased their latest and cutting-edge tools for conducting biomechanical analyses. Malaysia is scheduled to host the conference next year.





CRS collaborates with University of Chichester for Posthuman Walking Project

he UST College of Rehabilitation Sciences partnered with the University of Chichester in the United Kingdom in an ongoing effort to foster international research collaboration and recognize the research expertise of our Thomasian Physical Therapists. The signing of a research collaboration agreement in August was represented by the Center for Health Research Movement Sciences Supervisor Prof. Valentin C. Dones, III, Ph.D., and Physical Therapy Department Chairperson Asst. Prof. Donald G. Manlapaz, Ph.D.

Within the framework of this agreement, the two institutions will collaborate on the "Posthuman Walking Project (PWP)." The PWP aims to explore the significance of walks in various cultural and socioeconomic contexts, considering factors such as location, climate, and purpose. These walks encompass both work-related and leisurely strolls.

This research endeavor involves five partner universities in Canada, New Zealand, Norway, Philippines, and the UK. Each of these universities will select up to two partner-walkers who will play a central

UST, USP mark 5th joint symposium

the University of Santo Tomas and the University of Shiga Prefecture, Japan was celebrated with the 5th UST-USP Joint Symposium on August 14, 2023, via hybrid mode at the Central Laboratory Auditorium.

This symposium, with the theme "Updates on Freshwater Ecology and Wildlife Parasitology," is a testament of the long-standing collaboration of University of Santo Tomas and University of Shiga Prefecture, Japan.

The onsite and online participants were welcomed by the College of Science Dean Prof. Rey Donne S. Papa, Ph.D. He shared how the collaboration between the two institutions has been strengthened over time.

The symposium was officially opened by Prof. Naoshige Goto, Ph.D., Chair of the Department of Ecosystem Studies, School of Environmental Science, University of Shiga Prefecture. He expressed his support and excitement for this year's installment of UST-USP joint symposium since the COVID-19 pandemic restricted the previous symposium to an online platform. Furthermore, Mr. Elfritzson M. Peralta provided a brief symposium history and overview.

Studies by the Japanese and Filipino researchers from the two collaborating institutions were highlighted. The morning session saw lectures from Assoc. Prof. Gregorio L. Martin I, Ph.D. of the UST Faculty of Pharmacy; Prof. Misako Urabe, Ph.D., a professor from the University of Shiga Prefecture; and Ms. Justine De Leon from the UST Department of Biological Sciences.

Martin presented his work on the "Fight against Fascioliasis", which detailed his group's research in investigating the biology and dynamics between its host and of the Fasciola parasite. Urabe highlighted her study on Lake Biwa, one of the oldest freshwater bodies in Asia with endemic and diverse fishes and its associated parasites. Meanwhile, De Leon shared their limnological studies in Lake Taal, Batangas.

Madrunio delivers lecture before diplomatic envoys and scholars at 2nd China-ASEAN Forum on Language and Culture

rof. Marilu Rañosa-Madrunio, Ph.D., represented the Philippines at the 2nd China-ASEAN Forum on Language and Culture held from August 29 to 30, 2023 in Guiyang China

Madrunio spoke about World Englishes in the Digital Era. She was joined by linguists and language scholars from China, Malaysia, Indonesia, Brunei Darussalam, Thailand, Vietnam, Lao PDR, Singapore, Myanmar and Cambodia. Diplomats from ASEAN countries also graced the event.

In her lecture, she emphasized the importance of embracing the different varieties of English and how this can be disseminated through the use of technology. She likewise discussed the key issues and challenges associated with this language phenomenon.

Prior to the big event, she delivered lectures at Xiamen University and Quanzhou Normal University on mother tongue-based multilingual education (MTB-MLE) in the Philippines upon the invitation of the Silk Road Language and Culture Center at Quanzhou Normal University. Along with Xiamen University, Quanzhou Normal University serves as the center for language and culture in the People's Republic of China.

NUS science historian discusses Lake Lanao's endemic cyprinids

lecture titled "Baoulan to Kadurog: Histories of Life and Loss in Philippine Freshwaters" was held on September 8, 2023 at the Science Online Learning Environment Room (SOLE) of the UST Main Building.

The lecture was delivered by Dr. Anthony Medrano of the National University of Singapore (NUS), a science historian who specializes in biodiversity studies. Medrano is a Presidential Young Professor of Environmental Studies of Yale-NUS College and an Assistant Professor at the NUS Department of History.


His talk focused on the extinction of Lake Lanao's 15 endemic cyprinid fishes from the genus *Barbodes*, including the highly prized *Barbodes baoulan* which was eventually traced to the proliferation of an invasive fish species, *Glossogobius giuris*, which was introduced to the lake during the 1960s to augment local fisheries.

As a historian, Medrano also provided perspectives on the history of the discovery of the endemic cyprinids of Lake Lanao including the scientists who discovered the said species and documented the decline of Lake Lanao's biodiversity.

The lecture was attended by undergraduate and graduate students in Biology, as well as select academic staff of the Department of Biological Sciences.

The event was organized by undergraduate BS Biology major in Medical Biology students under 2MBio3 as part of their General Ecology (Bio 426) class under the supervision of Prof. Rey Donne S. Papa, Ph.D. ■



he UST Graduate School Office for Community Development in coordination with the Psychotrauma Clinic and the Guidance and Counseling cluster rolled out mental health awareness programs to various stakeholders from partner communities and government agencies respectively.

In collaboration with the UST Psychotrauma Clinic, a series of mental health seminars with the organic personnel of the National Capital Region - Regional Community Defense Group (NCRRCDG), including those belonging to other nearby units (for Phase 1) and those troops belonging to reserve force assigned to the different Community Defense Centers (for Phase 2).

This activity was conceptualized upon the initiative of Col. Ferdinand Rey Ga, Group Commander, to organize activities to maintain the mental well-being of the AFP troops.

From the UST Psychotrauma Clinic, Mr. Michael Edward Buenaflor, RN, MA, RPsy and Mr. Romelito Manuel D.S. Clorina, MA, RPm, RPsy, both UST academic staff, spoke about the importance of mental well-being in the performance of the soldiers' duties and the necessity of being able to assess the psychological situation of their companions.

The seminars were conducted at the Headquarters of the NCRRCDG at Camp Bonifacio, Taguig City in May 2023 while Phase 3 is being planned for the organic personnel of the Office for Reservist and Retiree Affairs (OG9) of the Philippine Army.

Another round of mental health seminars were conducted through the initiative of the students from the M.A. in Guidance and Counseling program, in collaboration with Barangay Sibulan in Nagcarlan, Laguna. The seminar titled "Mind that Matters: Mental Health Awareness Seminar" was held on May 27, 2023 to selected youth beneficiaries within the barangay and nearby vicinities. This activity is part of the service-learning component of the aforementioned graduate school program conducted through the guidance of Prof. Lucila O. Bance, Ph.D., of the Department of Psychology and Ms. Tita Sochaco from Brgy. Sibulan. The seminar addressed the common stressors encountered by the youth.
