UST tops off Henry Sy Sr. Hall at Manila campus

he University of Santo Tomas held the topping-off ceremony of the Henry Sy, Sr. Hall on October 7, 2023. This is a builder's tradition that highlights the placement of the final beam on top of the structure.

Faculty of Medicine and Surgery Dean Assoc. Prof. Ma. Lourdes D. Maglinao, M.D., said that "The birth of the Henry Sy, Sr. Hall will herald the adaptive transformatioan, witnessing how our 152-year old traditional medical school embraces innovative metamorphosis in response to the changing landscape of medical education."

Bearing the name of esteemed businessman Henry Sy, Sr., UST is grateful for the generous donation of Teresita Sy-Coson, Vice Chairman of SM Investments Corporation (SMIC), the Henry Sy Foundation, and the SM Foundation Inc.

The seven-storey building will serve as a hub for simulation in medical education, interactive student centered-learning, collaborative multidisciplinary research, and interprofessional education. It will also house the Sts. Cosmas and Damian Medical Simulation and Research Center, which will feature simulated emergency rooms, surgical suites, delivery rooms, adult and pedriatic intensive care units, and medical wards. There will also be consultation rooms fully equipped with low, medium, and high-fidelity mannequins and control rooms that academic staff can modify according to the complexity of a medical case. In addition, there will also be debriefing rooms capable of real-time observation and assessment of learners as well as playback of events for discussion, among other features.

"This paradigm shift is set to revolutionize medical and healthcare education and research, ultimately providing future Filipino physicians with the best and accessible 21st century medical education to better serve our country and our people. With cutting edge simulation technology, it will provide a realistic

Sy shared that the Henry Sy, Sr. Hall intends to elevate health education in the Philippines and it "stands as a symbol of our enduring commitment to education and its pivotal role in fostering social progress. Through strategic partnerships such as these, we've constantly supported academic excellence and development across the nation, recognizing that it's through education that we pave the way for a brighter future. This Hall embodies this vision, humbly contributing to the journey of progress through knowledge.'

Facilities Management Office Director Rev. Fr. Dexter A. Austria, O.P., thanked and congratulated the "countless hands and hearts that have contributed to its construction. Their dedication and expertise have brought us to this moment." This included the consultancy firm CA Ventura and Partners, led by its Principal Architect Rodolfo Ventura, who also serves as Dean of the College of Architecture, the general contractor AIMM Builders and Construction Supply led by Engr. James Liong, project management team JCV & Associates led by Engr. Jason Valderrama, and the UST Facilities Management Office.

Aside from the generous contribution SM Investments Corporation from (SMIC), the Henry Sy Foundation, the SM Foundation Inc., and Anargyroi: FMS Foundation Inc. played a significant part in the completion of the Henry Sy, Sr. Hall.

he University of Santo Tomas conferred the title of Professor Emeritus upon NAST Academician Maribel G. Nonato, Ph.D., in recognition of her many significant contributions to education and research. The solemn investiture was held on October 13, 2023 at the Dr. Robert Sy Grand Ballroom of the Bl. Buenaventura García Paredes O.P. Building.

Since she stepped into the University of Santo Tomas as a college freshman in the early 70s, Nonato has elevated the state of research in the field of Science and Technology, particularly Organic Chemistry, in the University, the country, and abroad. Now, almost 50 years later, the University of Santo Tomas is proud to honor one of its alumni and top administrators with the lifetime distinction of Professor Emeritus-the highest honor awarded by UST to its academic staff.

As part of the ceremony, she received the ceremonial hood, cap, ring, and medallion. The hood and cap represent her expertise, scholarly contributions, and the depth of knowledge and accomplishments that have contributed to the honoree's recognition as a distinguished academic. The ring represents the Professor Emeritus' enduring commitment to the academe, and her continued influence and mentorship. Lastly, the medallion is the University's acknowledgment of her dedication and prowess, which led to her significant impact on the academic community throughout her career.

Having been lauded and recognized by institutions of high repute, particularly the National Academy of Science and Technology who named her Academician, Dr. Nonato is currently the National Research Council of the Philippines (NRCP) Vice President and Chemical Sciences Division Chair. She is also a member of the Commission on Higher Education - Technical Committee in Chemistry.

She pioneered research on phytochemistry and biological activities of Philippine-grown species of the genus Pandanus, with more than 50 publications in internationally indexed journals. Her association with the plant is so widespread that an advisee of hers in the Graduate School, Dr. Christina Tan, named a newly

discovered Pandan species after her: Freycinetia nonatoi, a fitting tribute for a leading scholar fondly called the "Pandan Queen" by her colleagues and students.

Her discovery of novel and structurally unique pharmacologically important alkaloids from the genus Pandanus earned Nonato the NRCP's 2006 achievement award in chemical sciences, the Philippine Association for the Advancement of Science and Technology's 2016 Gregorio Y. Zara Award for Basic Research, the Philippine Federation of Chemistry Sciences' 2017 Shimadzu Achievement for Chemical Research, and the Philippine Regulation Commission's 2020 Outstanding Professional of the

Iniversity of Glasgow officials Prof. Clare McManus, Ph.D., Dean for Global Engagement South East Asia and Australasia, and Prof. Cristina Persano, Ph.D., Dean for Internationalization of the College of Science and Engineering, visited the University of Santo Tomas for a partnership renewal with the UST Office of International Relations and Programs (OIRP) on October 9, 2023.

The guests met with the officials of OIRP and College of Science, including the Dean Prof. Rey Donne S. Papa, Ph.D., Graduate School Psychology Cluster Program Lead and College of Science Assistant Dean Prof. Maria Claudette Agnes, Ph.D., and College of Science Psychology Program Chair Asst. Prof. Karen Katrina Trinidad, Ph.D. In the meeting, they shared insights on how the said activities can be brought into fruition.

OIRP started the meeting by reviewing the MOU between UST and GU. The said MOU was signed in 2018, and both parties agreed to renew the partnership with emphasis on intensifying student and faculty mobility and exploring the possibility of joint research in the area of health and well-being.

The plans include cross-border mobility: study abroad for pre-med students, research attachments, exchange studies for one term to a maximum of two terms, and sandwich programs for young faculty members of the Psychology department. They also discussed possibilities of virtual mobility: through joint symposia and delivery of collaborative online international learning (COIL), of which UST had a series of meaningful delivery of the said program under the EU SHARE. GU expressed its willingness to learn about the delivery of COIL as well as the framework implemented by OIRP.

Basas, Gozum of IR, CTRSE explore Care for Persons with Parkinson's

pringer's Journal of Religion and Health published a new article by Assoc. Prof. Allan A. Basas, Ph.D. and Mr. Ivan Efreaim A. Gozum of the UST Center for Theology, Religious Studies and Ethics and the Institute of Religion in their special issue on Spiritual Care for People with Parkinson's Disease and their Caregivers. The paper delves into the potential of Pope Francis' Culture of Encounter (CoE) to establish an ethical foundation that undergirds pastoral and health care for persons with Parkinson's Disease (PD), their family members, and caregivers.

In the article, Basas and Gozum provide an in-depth assessment of the documented experiences of people with PD, their families and carers. PD, an incurable illness, profoundly Mr. Gozum and Assoc. lexis Deodato S. Itao, a Ph.D. in Philosophy student from the UST Graduate School presented a paper at the recently concluded 2023 Societas Ethica Philosophica, Inc. (SEPI) International Conference on Christian Philosophy, Sustainability, and Development in the Philippines and Southeast Asia held at Silliman University, Dumaguete City from September 28 to 30, 2023. He presented "The Philosophical Art of Living: An Anatomy of the Care of the Self in the Later Foucault." In the paper, Itao examines the notion of the care of the self and presents it as an aggregate philosophical art of living by synthesizing and putting together into a coherent whole of Foucault's dispersed ideas about the ancient practice from his later works.

The SEPI International Conference was an event that brought together scholars and practitioners from different fields to discuss the intersection of Christian philosophy, sustainability, and development in the Philippines and Southeast Asia. The SEPI organized the conference in partnership with the Center for Philosophy and the Humanities and the Research Institute for Culture and Language of the Polytechnic University of the Philippines (ICLS-PUP) and the Department of Philosophy of Silliman University.

The CoE encourages empathy and understanding of a PwPD's physical limits, emotional worries, and day-to-day challenges to create a kind and encouraging environment. Similarly, using CoE can help create a more Christ-like approach to healthcare.

Itao's presentation was well-received by the audience, and they were particularly interested in his insights on how Foucault's ideas on the care of the self can be applied to the context of Christian philosophy and sustainable development in the Philippines and Southeast Asia.

Itao is a Ph.D. student whose research interests include Christian philosophy, hermeneutics, ethics, and ancient philosophy.


The Angelus is a Marian devotional prayer that commemorates the moment the Archangel Gabriel announced that the Virgin Mary would conceive and give birth to the Son of God. The practice is typically observed at dawn, noon, and dusk, so the works often depict the hues of twilight and the warmth of the sunset glow.

As the exhibit focuses on family prayer and coincides with the month of the Holy Rosary, the space includes an oratorio, or prayer room, with an altar that includes figures of the Virgin Mary and the Child Jesus.



Climate change can cause next pandemic, health expert tells UST-hosted int'l confab

public health expert thinks the Philippines may need to address the pressing impacts of climate change especially since the situation can possibly spark the next pandemic.

Dr. Ramon Lorenzo Guinto of St. Luke's Medical Center said that such health impacts of climate change may come from "zoonotic spillovers" or viruses that get transmitted from vertebrate animals to humans.

These spillovers, he adds, are on top of SARS-CoV-2 -already "classified" by health experts as a zoonotic disease even if the animal reservoir of this virus is yet to be precisely determined.

Which is why for Guinto, public health systems must be "climate-resilient".

"(With the Philippines) being the heart of the climate crisis, the challenges include the interlocking of mental health and climate change in the Philippines, the failure of health systems to be ready in crisis, and the progress of the country to achieve the Sustainable Development Goals (SDGs)



has been reversed and derailed," Guinto said at an international seminar-workshop on disaster management in Southeast Asia held at the University of Santo Tomas. Guinto's remarks come at a time when the 28th Conference of the Parties to the

UN Framework Convention on Climate Change (or COP28) is set to be staged November 30 to December 12 in Dubai. United Arab Emirates.

Looming in the backdrop is the projection by the World Meteorological Organization (WMO) last May of a 66 percent likelihood that near-surface global temperatures will be 1.5°C hotter - for at least one year - between 2023 and 2027.

There is also a 98 percent chance, WMO adds in its projection (issued last May), that one year within the next five years "will be the warmest on record".

"WMO is sounding the alarm that we will breach the 1.5°C level on a temporary basis with increasing frequency," said WMO Secretary-General Prof. Petteri Taalas.

And if these rising temperatures lead to disease outbreaks or worse a pandemic similar with COVID-19, Guinto said public health systems must not only be better governed but become more responsive compared to the experiences during the COVID-19 pandemic.

"Solutions here," Guinto adds, include building better health and climate-resilient systems, good governance, financing that's readily available to be tapped, and community building as the first line of defense." Guinto said at the workshop Governing Complex Disasters in Southeast Asia held at UST.

Academics from Universiti Brunei Darussalam, Deak University, Brown University, and UST, as well as NGOs such as Philippine Disaster Relief Foundation (PDRF) and Curiosity.PH, co-organized the international seminar-workshop.

Panel presentations, a simulation on disaster response operations at PDRF's facility in Clark, Pampanga, and research presentations marked the international seminar-workshop.

Swedish Ambassador to the Philippines Dr. Annika Thunborg concurred with Guinto and reiterated Sweden's support to overall global initiatives surrounding climate change response and COVID-19 vaccination through AstraZeneca. The Ambassador served as keynote speaker during the seminar-workshop.)




